1. INTRODUCTION:

The Elias Motsoaledi Local Municipality **request for proposal(s): Rehabilitate of ablution facility (also known as Standard Bank toilets): remainder of erf 100 Groblersdal town.** Elias Motsoaledi Local Municipality intends to get into a memorandum of understanding with the quest of restoring the public ablution facility situated on the remainder of erf 100, Groblersdal town to its original state.

1.1 BACKGROUND:

It is a known fact that delivering services is one of the core responsibilities of the Municipality. This amongst others includes provision and promotion of easy access to facilities named above. To compile the above, such facilities shall be safe and secure, taking into cognizance the context of these terms of reference. Presumably, nodes that are equipped with all necessary support amenities have the likelihood of encouraging the optimal use of outdoor spaces. The latter behavior shall result in easy association and owning up of such spaces by the public.

1.2 PURPOSE:

The purpose of this document is to set out terms of reference to invite proposals whose quest is to resuscitate the above said amenities/ services for the Elias Motsoaledi Local Municipality. This undertaking will to a certain extent enable the Municipality to deliver a service as expected by the public and furthermore that through delivering such a service, local benefits are also realized.
