REPLACEMENT OF HHFE UNITS

iThemba LABS is seeking the services of an Approved Service Provider to source, deliver and install Hand Held Fire Extinguishers (HHFE) which complies with all relevant Regulatory and SANS requirements.

A portable fire extinguisher, also known as a portable non-aerosol fire extinguisher or hand-held fire extinguisher, is an appliance and type of fire extinguisher that contains a liquid, gas or chemical agent and a propellant that may be rechargeable or non-rechargeable to control or extinguish a small fire.

iThemba LABS currently has approximately 350 Chubb Hand Held Fire Extinguishers which complies with BS 5045/3/A/S Standard. These units are mostly Carbon Dioxide (CO2) and Dry Chemical Powder (DCP) based Hand Held Fire Fighting Extinguishers.

The selected service provider will be required to provide and install new, SANS 1475 and 10105 compliant hand-held Fire Extinguishers in all areas of the Facility and remove all existing hand-held Fire Fighting Equipment to a designated storage area at iThemba LABS. The removed equipment will remain the property of iThemba LABS.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
