PROCUREMENT AND INSTALLATION OF POLY DOSING PUMPS AT THE NGAGANE WATER PURIFICATION PLANT

1. Introduction:

As a bulk water supplier, it is the intention of uThukela Water to request quotations from suitable suppliers for the supply, delivery and installation of Poly dosing pumps at the Ngagane Water Purification Plant.

2. Background:

The Ngagane Water Purification Plant is situated approximately 11km's from Newcastle. Raw water is purified, and potable water is pumped to several reservoirs. Poly dosing pumps are part of the water purification process.

3. Requirements:

To supply, deliver, install, and commission Poly dosing pumps at the Ngagane Water Purification Plant.

 Bids will be adjudicated in terms of the Preferential Procurement Regulation, 2022 pertaining to Preferential Procurement Policy Framework Act, 5/2000, UTW SCM Policy and other applicable legislations, and will be based on 80/20 points system. Preference points will be awarded to service providers using their B-BBEE status level of contribution.

- National Treasury General Conditions of the contracts are applicable.
