1. PURPOSE

The purpose is to appoint a service provider to design, print and distribute a staff bi-monthly newsletter in seven (7) SANParks regional offices for a period of three (3) years.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

SANParks requires the services of a service provider to design, print copies and distribute a staff bi-monthly newsletter in seven (7) SANParks Regional Offices for a period of 3 years.

3.1 Online Staff Newsletter

a) Design and layout and publishing

- Online version of staff newsletter containing design, images, hyperlinks (32) and pages with content, hosted on a separate site managed by the successful bidder.
- Design of 3 concepts for front end/cover and interior for the online and printed A4 Size: 297mm X 210mm version of the staff newsletter for approval
- Designing of adhoc artwork/posters for interior of the newsletter where required
- SANParks will supply news content and photos.
- Supplier is to adhere to CI manual which will be provided by SANParks.

b) Writing, Editing and Proofreading

- Correct and modify supplied content, track modifications and ensure that content flows from a story perspective. SANParks to supply content and images.
- Ensure that content is grammatically correct, with no typos or spelling errors.
- Proofread the final version of the newsletter.

3.2 Printed Magazine

a) Design and layout and printing

- Design of 3 concepts for front cover
- Design interior of the magazine, including adhoc artwork/posters for interior of the newsletter where required.
- Printing of 2500 copies in A4 Size: 297mm X 210mm

- Number of Pages: 32 Pages including covers

- Colour: Printing in Full Colour

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”**
means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
