## **1. PURPOSE**

Nongoma Local Municipality seeks to source a panel of service providers to supply accommodation and conference venue as and when required for a three (3) year period.

## **2. AVAILABILITY**

The service provider should be able to provide accommodation and conference venue under urgent and emergency conditions.

## **3. DURATION**

The duration of the contract shall be the minimum of three (3) years from the date of appointment.

The probation period for the service provider shall be six (6) months. If the municipality is not satisfied with the services of the service provider within the probation period, then it terminates the services of the service provider and appoints another service provider. The service provider will be evaluated based on performance atleast twice a year and prior arrangement will be made regarding such evaluation date.

## **4. EVALUATION OF THE BID**

The following evaluation method will be used:

- After the closing date of the bid invitation, an appointed bid evaluation committee of Nongoma Local Municipality will evaluate the proposals of the bidders.
- The committee will individually evaluate each of the bid proposals received against the approved criteria as stated below.
- All proposals submitted will be evaluated on two (2) categories:
  - Functionality (technical content)
  - Specific goal

Bids are evaluated in accordance with the Preferential Procurement Policy Framework Act (MFMA), using the 80/20 split.

**The evaluation of the bids will be conducted in the following:**

Firstly, the assessment of functionality must be done in terms of the evaluation criteria and minimum threshold value of **35 points**. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation.

During phase two, only the qualifying bids are evaluated in terms of 80/20 preference points systems. 80 points will be used for price only and the remaining 20 points are for specified goals.

For functionality, the following criteria will be applicable and the maximum value of each criterion is indicated as below:

The points associated with the comprehensive proposal will be awarded as reflected in the following table.

- 1.6 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.7 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **tender** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **price** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **rand value** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **tender for income-generating contracts** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **the Act** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

### 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

Certificate of Independent Bid Determination

- 1 This Municipal Bidding Document (MBD) must form part of all bids<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
