- 1.1 Collection and delivery of the vehicle will be at the Municipal workshop in St. Croix Street Jeffrey's Bay.
- 1.2 Delivery of the vehicle must be on Mondays to Fridays between 07H30 to 15H00 and on Friday between 07H30 and 12H00.

## 2. **KEY PERFORMANCE INDICATORS**
