- The Supply Chain Management Policy of Ray Nkonyeni Municipality will apply. The Council reserves the right not to accept the lowest bid or any bid and reserves the right to accept the whole or part of the bid, or to reject all bids and cancel the notice to bid.
- Bids that are submitted late, incomplete, not initialled on each page, unsigned or by facsimile, electronically or not completed in black ink will be rejected and not accepted for further evaluation.
- Only service providers registered in the Central Supplier Database (CSD) will be considered. Bidders must attach proof of registration, and failure to attach such will result in a bid not evaluated further.
- Members or Directors of Companies or Service Providers who are state employees are not allowed to bid or quote.
- **Foreign Qualification to be verified by SAQA and verification to be attached.**
- The bidder must submit proof of experience in managing outdoor/ billboard advertising within South Africa.
- Unsuccessful bidders will be informed of the Bid outcome through the Municipal website. SPECIFICATIONS/ TERMS OF REFERENCE:

THE APPOINTMENT OF A PANEL – BILLBOARD ADVERTISING SPACE WITHIN RAY NKONYENI MUNICIPAL JURISDICTION

SPECIFICATION AND INDICATIVE SCOPE OF WORK

1.1 Objective of the Bid

Respondents will be expected to provide proof that they have a thorough knowledge of the outdoor advertising industry and the marketing of advertising space. In addition, they must have the ability to administer Billboard advertising structures on spaces allocated to them by the Municipality. An appointed respondent will be granted short term concession rights for the management at the cost of the respondent for Billboard advertising structures, including the supply, installation, maintenance and operation of Billboards advertising, within the Ray Nkonyeni Municipal jurisdiction. Respondents are to provide proof to the satisfaction of the Municipality that they have the experience, the resources and the ability to manage a contract of this nature.

The main aim of the tender bid is to:

- Modernise advertising and advertising space within Ray Nkonyeni Municipality
- Identify additional sites suitable for billboard advertising in response to attracting revenue for the Municipality.
- Categorise billboard advertising.
- Demarcate billboard advertising areas into specific zones. These zones are divided into four, namely: Hibberdene to Umtentweni, Port Shepstone CBD to Ezingolweni and including Gamalakhe, Oslo beach to Margate & Ramsgate to Port Edward.

The submission of bidders, who are unable to provide the requisite proof, will be disqualified and will not be considered further.

1.2 Conditions

- 1.2.1 An appointed bidder shall be the sole contractor to manage the administration of Billboard advertising structures on appointed sites on behalf of the Municipality and to install the Billboards in accordance with the specifications.
- 1.2.2 The bidder will be responsible for the identification and removal of string, cord, wire or material of whatever nature used to secure such advertising signs, from the Billboard advertising structures.
- 1.2.3 As part of the proposal submission, the respondent must submit an implementation plan that must show how the applicant intends to generate revenue sustainably for the Municipality, while working within the set of constraints and meeting defined obligations. A plan which indicates the implementation and roll out of the structures, a plan for the management and

maintenance thereof, a plan for the removal and relocation of Billboard advertising structures and a plan for the administration of Billboard advertising.

- 1.2.4 The sites on which the Billboard advertising structures may be erected shall be approved by the Municipality before the Billboards are erected.
- 1.2.5 An appointed bidder shall, in accordance with the implementation plan, complete the supply and installation of the Billboard advertising structures within three (3) months from the date of commencement of the agreement.
- 1.2.6 The bidder shall keep a record of all Billboard advertising structures supplied and installed according to the type of Billboard advertising structures and the date and location of such installation and supply such record to the Municipality on a monthly basis.
- 1.2.7 Should the Billboard advertising structures be damaged as a result of the installation or removal of the structure or fixture by the bidder, in such instance the appointed bidder shall repair the damaged Billboard advertising structures to their original state.
- 1.2.8 Should it be necessary to remove any Billboard advertising structures as a result of road works of whatever nature or the relocation or upgrading of services or whatever other reason deemed necessary by the Municipality, the Billboards with advertising panels is to be removed by the bidder within fourteen (14) days of written notification to move such structure. Should the bidder fail to adhere to the Municipality's request, the Municipality shall be entitled to remove the structure at the cost of the bidder. All costs involved in the relocation or removal of the structure shall be for the account of the bidder. The Municipality shall not be liable for any damages of any nature arising from such actions.
- 1.2.9 The Municipality may in its sole discretion carry out any maintenance and effect any alterations to its property at any time and should such maintenance and/or alterations affect Billboard advertising structure, the Municipality shall not be liable for any damage to the structure arising from such maintenance and/or alterations, whether such damage was caused by negligence, or was the result of the action of the Municipality, its employees, contractors or representatives. The Municipality shall furthermore not be liable for any loss of income or any damage, caused by such maintenance/alterations, that the service provider may suffer.

2. Council By-law and Other Legislations

All signs to be erected and/or displayed within the area of jurisdiction of the Municipality must, comply with all other applicable legislation, including but not limited to:

- Promotion of Administrative Justice Act, 2000 (Act 3 of 2000);
- National Environmental Management Act, 1998 (Act 107 of 1998) (as amended);
- Occupational Health and Safety Act, 1993 (Act 85 of 1993);
- National Building Regulations and Building Standards Act, 1977 (Act 103 of 1977);
- National Road Traffic Act, 1996 (Act 93 of 1996);

- National Road Traffic Regulations, 2000;
- National Heritage Resources Act, 1999 (Act 25 of 1999);
- Municipal Finance Management Act (Act 56 of 2003);
- South African Schools Act (Act 84 of 1996); and
- Zoning Scheme Regulations.

3. Financial Offer

- 3.1 In addition to the obligations captured under the description of this tender document, the bidder shall pay to the Municipality a flat rate rental income per structure, per month irrespective if the advertising structure has a display or is vacant.
- 3.2 The amount(s) payable to the Municipality in terms of the agreement shall be payable on or before the 7th day of each month from the commencement date.
- 3.3 The amount(s) payable to the Municipality are subject to the payment of VAT and shall be free of any bank exchange, commission or other deduction of any nature.
- 3.4 The bidder shall submit a monthly income statement together with its monthly payment, and shall be obligated to also submit an annual audited financial statement relating to the turnover from the Billboards per site with advertising panels within 3 (three) months after the financial year-end to the Municipality.
- 3.5 The cost of supply, installation, maintenance and all other costs of all Billboard advertising structures shall be borne by the bidder.
- 3.6 All Billboard advertising structures shall at all times remain the property of the service provider.
- 3.7 The cost of supply, installation and maintenance of all, Billboard advertising structures as well as the replacement and relocation of advertising Billboards where required shall be borne by the bidder.

4 Technical Specifications

- 4.1 The respondent must submit the proposed design of Billboard advertising structures as per the required type of Billboard per site. The designs submitted must be presented in full colour depicting the front and back elevations, dimensions of the structure and display face, the materials to be used, the finishes, method of installation, an estimate of the weight of the structure, and the manner in which the advertising panels is to be affixed to the Billboards.
- 4.2 All structures or fixtures to Billboards shall not be permanent in nature and shall be affixed in such a manner that they may easily be removed if and when necessary by the Municipality without any damage to the Billboard structure.

- 4.3 The Billboard shall not be erected within 50m from the on and off-ramp of public roads from overhead traffic directional sign or 100m from the nearest edge of an intersection on an arterial road and shall comply with SAMOAC, Signage Bylaws, the Road Traffic Act, other applicable legislation and traffic requirements.
- 4.4 Billboard may not to have an overall height in excess of 7m in landscape format or 12m in portrait format above the surface of natural ground level or of the road level to which it is aimed.
- 4.5 The Billboard advertising are to be made of material that is capable of withstanding all weather conditions and be vandal proof with durable finishes.
- 4.6 All materials used in the system and auxiliaries shall be new and be manufactured of non-combustible and non-flammable materials. All galvanized materials used shall be hot-dipped for corrosion protection purposes.
- 4.7 The manner of placing and securing of Billboards must be indicated and signed off by the successful bidder.
- 4.8 All Billboard advertising structures need to be utilized to maximum potential or alternatively offered to Council at no extra charge to advertise municipal wide projects/events, as and when required. The bidder shall maintain all Billboards with advertising panels in a fit and proper condition to the satisfaction of the Municipality.
- 4.9 Vacant structures may contain only the name, logo and contact information of the bidder or, at no cost, when required any Municipal logo, information, slogan or message approved by the Municipality, on the inner plate of the structure in order to serve as identification filler. Any change to the design of the structure shall be submitted to the Municipality for approval prior to fixture thereof.
- 4.10 Preference may be given to green or low-tech solutions (that would continue to function without energy use or without external electricity supply, for example). However, proposals of various options may be considered, and should be motivated in writing by the tenderers.

The below diagram is an example of billboard depending on landscape and it is for illustration purposes only in terms of size.

- 5.1 The site description, co-ordinates and the type of billboard must be listed in a table similar to the above and it must be included in the Financial Proposal Envelope with the proposed revenue for the proposed Billboard. (Failure to comply with this requirement will invalidate the tender)
- 5.2 Bidders must note that in an event of more than one bidder proposing the same site, the Municipality will consider the highest revenue that is being proposed for a Billboard structure.
- 5.3 Assessment of this opportunity will be done in compliance with all the tender requirements enlisted in this document for both Technical proposal and Financial proposal.
- 5.4 Letters/ Agreements for the utilization of private property must be attached. Failure to comply with this requirement will invalidate the proposed site.

6. REPORTING AND ACCOUNTABILITY

During the execution of the project, the service provider must submit monthly progress reports and attend quarterly meetings at intervals as determined by the project team managing the service provider. The service provider is further expected to attend any emergency meeting that may arise.

All electronic and hard copy information captured/utilised to provide the output of the project remains the property of Ray Nkonyeni Municipality. This data should be surrendered to the department at the end of the project, and it cannot be used or shared, whether for profit or otherwise with any other party, without written permission from Ray Nkonyeni Municipality. The Municipality will retain copyright and all associated intellectual rights relating to the project.

The project will be signed off by the Acting Head of Department: Development Planning Services.

7. PROJECT QUOTATION AND PERFORMANCE MEASURES

- 7.1 A detailed project budget must be provided in accordance with the deliverables and time frames.
- 7.2 Each proposed project activity should be analysed in terms of the required inputs and these inputs must have costs attached thereto.
- 7.3 The performance measures for the delivery of the project will be closely monitored by the Municipality.

8. DURATION OF AGREEMENT

- 8.1 The period of the agreement shall be for nine years and eleven months only, commencing on the date of the agreement.
- 8.2 At the expiry or cancellation of this agreement, the bidder shall be given twenty-one (21) working days' written notice to remove the Billboards advertising structures and leave the

sites in a clean and tidy condition, at its own expense, to the satisfaction of the Municipality. The structures will be deemed illegal should the bidder fail to comply with the notice period. The Municipality shall then carry out the necessary work at the bidder's expense and be entitled to sell or otherwise dispose of any such property removed by it and retain the total proceeds received to defray any expenses and storage costs incurred by the Municipality. In the event that the proceeds received are less than the expenses incurred by the Municipality the difference will be recovered from the bidder in line with the Municipality's tariff of charges.

- 8.3 As part of the development plan that is required as part of this contract, a Service Level Agreement needs to be in place for the sub-contracting of a local contractor.
- 8.4 The bidder will be expected to utilise the rights granted to them within 3 months of being awarded the contract.

9. TERMS AND CONDITIONS OF THE BID

- 9.1 The bases for appointment shall be the proposal as submitted and further elaborated through presentation if Council applied the presentation option, but subject to further negotiations between service provider and the municipality in case any gaps identified between the Terms of Reference and proposal.
- 9.2 As a basis for Awarding of the proposal will be subject to the Service provider's expressed acceptance of the Municipality Supply Chain Management's general contract conditions. The municipality and Service provider shall sign a Service Level Agreement upon appointment.
- 9.3 The service provider should commence the project within five (5) days after receiving the letter of appointment and the service level agreement signed.
- 9.4 During the execution of the project, the service provider is required to submit reports on the progress of the project. It is the responsibility of the service provider to coordinate progress report meetings and have a representative/s assigned to taking minutes during the meetings.
- 9.5 Any deviation from the project plan should be put in writing and signed by the project manager.
- 9.6 Any suggestions during the progress meetings, once accepted by both parties, shall form part of the contract.
- 9.7 The Municipality reserves the right to terminate the contract in the event that there is clear evidence of non-performance.
- 9.8 The SLA to be entered into with successful bidders will stipulate a minimum monthly payment (tariff of charge or percentage offered ... whichever is greater).

10. INDEMNITY

- 10.1 The Ray Nkonyeni Municipality accepts **NO** responsibility for any damage to or loss of property, injuries or death of any person that may occur during execution of the project.
- 10.2 The Municipality will not be held responsible for any costs incurred by the service provider in the preparation and submission of quotation. Traveling costs and time spent or incurred between home and office of the service provider.
- 10.3 The Municipality reserves the right not to award any of the quotes/ proposal and not to award the contract to the lowest price as well as to renegotiate the price.

General Conditions of Contract

- 1. Definitions**
- 1.1 The following terms shall be interpreted as indicated:
- 1.2 “Closing time” means the date and hour specified in the bidding documents for the receipt of bids.
- 1.3 “Contract” means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.4 “Contract price” means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.5 “Corrupt practice” means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.6 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.7 “Country of origin” means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.8. “Database application form” means the application form required by the Ray Nkonyeni Municipality to be filled in by the successful Bidder, following the award of the contract, for inclusion on the RNM database before payment is made.
- 1.9 “Day” means calendar day.
- 1.10 “Delivery” means delivery in compliance of the conditions of the contract or order.
- 1.11 “Delivery ex stock” means immediate delivery directly from stock actually on hand.
- 1.12 “Delivery into consignees store or to his site” means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the goods are so delivered and a valid receipt is obtained.
- 1.13 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.14 "Force majeure" means an event beyond the control of the

supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

- 1.15 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.16 "GCC" means the General Conditions of Contract.
- 1.17 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.18 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the goods covered by the bid will be manufactured.
- 1.19 "Local content" means that portion of the bidding price, which is not included in the imported content provided that local manufacture does take place.
- 1.20 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.21 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.22 "Project site," where applicable, means the place indicated in bidding documents.
- 1.23 "Purchaser" means the organization purchasing the goods.
- 1.24 "Republic" means the Republic of South Africa.
- 1.25 "SCC" means the Special Conditions of Contract.
- 1.26 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.

- 1.27 “Supplier” means the successful bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.
- 1.28 “Tort” means in breach of contract.
- 1.29 “Turnkey” means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.
- 1.30 “Written” or “in writing” means hand-written in ink or any form of electronic or mechanical writing.
- 2. Application**
- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services (excluding professional services related to the building and construction industry), sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific goods, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.
- 3. General**
- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a nonrefundable fee for documents may be charged.
- 3.2 Invitations to bid are usually published in locally distributed news media and on the municipality/municipal entity website.
- 4. Standards**
- 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.
- 5. Use of contract documents and information inspection**
- 5.1 The supplier shall not, without the purchaser’s prior written consent, disclose the contract, or any provision thereof, or any specifications, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser’s prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned

(all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.

- 5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

- 6. Patent rights** 6.1 The supplier shall indemnify the purchaser against all third party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

- 6.2 When a supplier developed documentation / projects for the municipality / municipal entity, the intellectual, copy and patent rights or ownership of such documents or projects will vest in the municipality / municipal entity.

- 7. Performance security** 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.

- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.

- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:

- (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
- (b) a cashier's or certified cheque.

- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified.

- 8. Inspections, tests and analyses** 8.1 All pre-bidding testing will be for the account of the bidder.

- 8.2 If it is a bid condition that goods to be produced or services to be rendered should at any stage be subject to inspections, tests and analyses, the bidder or contractor's premises shall be open, at all reasonable hours, for inspection by a representative of the purchaser or organization acting on behalf of the purchaser.

- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the

contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.

- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the goods to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the goods or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such goods or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Goods and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract goods may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods, which do comply with the requirements of the contract. Failing such removal the rejected goods shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.
- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 22 of GCC.

9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1 Delivery of the goods and arrangements for shipping and clearance obligations, shall be made by the supplier in accordance with the terms specified in the contract.

11. Insurance

- 11.1 The goods supplied under the contract shall be fully

insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified.

- 12. Transportation** 12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified.
- 13. Incidental services** 13.1 The supplier may be required to provide any or all of the following services, including additional services, if any:
- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
 - (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
- 13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.
- 14. Spare parts** 14.1 As specified, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:
- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
 - (b) in the event of termination of production of the spare parts:
 - (i) advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.
- 15. Warranty** 15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further

warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

- 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise.
- 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4 Upon receipt of such notice, the supplier shall, within the period specified and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment

- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated.
- 16.5. Payment will only be made if the supplier has filled in and submitted the necessary database application form to the satisfaction of the Chief Financial Officer.

17. Prices

- 17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized or in the purchaser's request for bid validity extension, as the case may be.

18. Variation orders

- 18.1 In cases where the estimated value of the envisaged changes in purchase does not vary more than 15% of the total value of the original contract, the contractor may be instructed to deliver the goods or render the services as such. In cases of measurable

quantities, the contractor may be approached to reduce the unit price, and such offers may be accepted provided that there is no escalation in price.

- 19. Assignment** 19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
- 20. Subcontracts** 20.1 The supplier shall notify the purchaser in writing of all sub-contracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.
- 21. Delays in the supplier's performance**
 - 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
 - 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
 - 21.3 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the goods are required, or the supplier's services are not readily available.
 - 21.4 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.
 - 21.5 Upon any delay beyond the delivery period in the case of a goods contract, the purchaser shall, without cancelling the contract, be entitled to purchase goods of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.
- 22. Penalties** 22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed

goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

- 23. Termination for default**
- 23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
 - (b) if the supplier fails to perform any other obligation(s) under the contract; or
 - (c) if the supplier, in the judgement of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner, as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.
- 23.5 Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchaser actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

- (a) the name and address of the supplier and / or person restricted by the purchaser;
- (b) the date of commencement of the restriction;
- (c) the period of restriction; and
- (d) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

- 23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Bid Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the supplier to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the supplier in regard to goods or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

25. Force majeure

- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination

- 26.1 The purchaser may at any time terminate the contract by giving

	for insolvency		written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to the purchaser.
27.	Settlement of disputes	27.1	If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
		27.2	If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
		27.3	Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
		27.4	Notwithstanding any reference to mediation and/or court proceedings herein,
		(a)	the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
		(b)	the purchaser shall pay the supplier any monies due the supplier for goods delivered and / or services rendered according to the prescripts of the contract.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

1. This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
2. Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
3. Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
