The scope of work measured in this BOQ document in broad terms comprises of the following:

General building, electrical, glazing, plumbing, carpentry, civil, mechanical, fire systems ETC

The anticipated contract period is **one (1) month** but the contractor must indicate and plan on the period he anticipates to complete all work, the construction works should commence within (7) days of the appointment and issuing of the purchase order, failure to do so will result in penalties and cancellation of the purchase order.

GENERAL

- 13 All Prime Cost amounts and Provisional Sums are nett. No discount will be allowed to the Contractor.
Note: All sub-contractors are direct contractors to the main contractor.
- 14 Where applicable and unless otherwise described, all rates must include for the necessary scaffolding not exceeding 5m high above bearing level AND also for dust screens & tarpaulins etc. where required
