SPECIFICATION/DETAILS AND CONDITIONS OF SALE

1. SCOPE:

1. The used oil sites may be inspected by arrangement with Petrus Pooe at the Municipality's Auctioning Yard at 31 Von Wielligh Street, Pretoria West Tel 012 358 6718, between the hours of 08H00 to 15H00 on Mondays to Fridays.
2. The successful tenderer must be a company in the oil recycling industry and may not make use of a sub-contractor to remove the used oil.
3. The items are offered for sale "voetstoots", i.e. without guarantee as to its actual condition.
4. The successful tenderer shall, immediately on acceptance of his/her tender, deposit a sum of R20, 000-00 to the Chief Creditors Section, which amount will be required in cash or a bank guaranteed cheque.
 - 4.1 The Chief Creditors will issue a receipt for the full amount.
 - 4.2 When used oil is collected, the receipt must be presented to the official/ Storekeeper in charge.
 - 4.3 The used oil must be removed from the sites within seven (7) days from the date of notification, but in no case shall the used oil be removed before sufficient funds are available on the tenderers credit worthy sheet at the offices of the Disposal Store, attention Lynette Greyling (telephone number 012 358 6707) at 31 Von Wielligh Street, Pretoria West.
 - 4.4 The total value of the used oil collected will in each case be deducted from the deposit of R20, 000-00. The total value of the used oil collected may not exceed the deposit received. If the deposit amount is exceeded, the further collection of used oil will only be allowed once payment of an additional deposit of R20, 000-00 to the Chief Creditors section is received.
 - 4.5 After the expiry of the contract the credit balance of the deposit amount will be refunded.
 - 4.6 When collecting used oil, the successful tenderer will be required to sign the Delivery note for used oil received.
5. If any dispute of difference should arise between the tenderer and the Tshwane Metropolitan Municipality, concerning the sale of the used oil, such dispute or difference shall be referred to the City Manager whose decision is final and binding on all parties, without appeal.
6. Any damage to Municipal property during the removal of the items shall be make good by the Municipality at the contractor's expense. Therefore, contractors are advised to take out suitable insurance to cover such damages.
7. From the date of acceptance of the quotation, the items will remain on site entirely on the purchaser's risk, and if not removed within the time stipulated in Clause 6.3, the Municipality reserves the right to dispose of the items after having given fourteen (14) days' notice to the purchaser concerned. Any loss sustained by the Municipality through so disposing of the items shall be done by the aforesaid tenderer and if necessary shall be recoverable by legal process.

8. Evaluation criteria

The bid will be evaluated in two stages. The evaluation will be done as follows:

 - Bidders are required to submit supporting documents for their bids to claim the specific goal points.
 - Non-compliance with specific goals will not lead to disqualification but bidders will not be allocated specific goal points. Bidders will score points out of 80 for price only and zero (0) points out of 20 for specific goals.
 - Cot shall act against any bidder or person when it detects that the specific goals were claimed or obtained on a fraudulent basis.

9. VALIDITY PERIOD

The validity period for the tender after closure is 90 days. CoT shall have right and power to extend any tender validity period beyond any initial validity period set and subsequent extensions. SCM shall ensure that an extension of validity is requested in writing from all bidders before the validity expiry date. Extension of validity shall be finalized while the quotations/bids are still valid.

Note:

- Accept that the submission of a tender shall be construed as an acknowledgement by the tenderer that he is satisfied with, where applicable, the insurance cover the employer will affect under the contract.

10. Condition

1. The successful tenderer shall remove the items at his/their own expense and must be in possession of the necessary vehicles and equipment to be able to remove the oil.
2. The truck or oil pump used to extract the oil must be fitted with a meter that measures the amount of oil taken.
3. The highest price offered per litre of oil will be accepted.
