F.3.11.9. Scoring Quality

Tenderers are to submit information in respect of the following criteria upon which they will be scored for Quality. Failure to submit the relevant information will/or may result in zero scores.

The quality will comprise scores for the following based on criteria indicated in the respective tender returnable:

- i) A maximum of **30 points** will be awarded for relevant qualifications and demonstrated experience of the proposed Site Agent/ Construction Manager.
- ii) A maximum of **30 points** will be awarded for qualifications and demonstrated experience of the proposed Site Foreman.
- iii) A maximum of **30 points** will be awarded for demonstrated experience with respect to undertaking construction of vehicular bridge structure projects.
- iv) A maximum of **10 points** will be awarded for ownership of construction plant and equipment.

Score quality, rejecting all tender offers that fail to score the minimum number of **70% (70 out of 100)** of the points for quality stated in the tender data. Point system for functionality will be as per the table below:

CURRICULUM VITAE OF KEY PERSONNEL

CV's and Certified Qualifications of each key personnel member must be submitted.

- Site Agent/ Construction Manager with NQF level 6 (National Diploma), equivalent or higher in Civil Engineering or built environment.
- Foremen / Supervisors with relevant experience.
