AN APPOINTMENT OF SERVICE PROVIDER TO SUPPLY AND DELIVER 2 x RING MAIN UNITS (RMU) WITH PROTECTION SETTINGS

Bidders are hereby invited from suitable service providers for an appointment of service provider to supply and deliver 2 x ring main units (RMU) with protection settings.

Bids must be completed in accordance with the conditions contained in this bid document and sealed in an envelope clearly marked: **"BID NO.: 06/26/27– APPOINTMENT OF A SERVICE PROVIDER TO SUPPLY AND DELIVER TWO (2) CTC THREE-WAY RING MAIN UNITS (RMUs) WITH PROTECTION SETTINGS"**. Bids must be deposited in the tender box at the reception of the Civic Centre, 2 Kingfisher Road, Mandeni, no later than **12H00 on Wednesday, 23rd September 2026** when bids will be opened in public. The closing time will be determined by the municipal clock displayed at reception. The bidder's name and address must be clearly written on the sealed envelope. Late, e-mailed or faxed bids will not be considered. Only bidders registered on the Central Supplier Database (CSD) will be considered.

Canvassing in any form of gift to Council is strictly prohibited and will lead to the disqualification of the bid.
