TERMS OF REFERENCE

APPOINTMENT OF A B-BBEE VERIFICATION AGENCY TO CONDUCT THE B-BBEE VERIFICATION PROCESS FOR THE 2024-25 FINANCIAL YEAR

1. OBJECTIVE

- 1.1 The objective of the project is for the Department of Cooperative Governance and Traditional Affairs (COGTA) to obtain the services of a competent B-BBEE verification agency with sufficient experience to conduct the BEE verification process for the 2024/2025 financial year.

2. DISCUSSION

- 2.1 The sphere of Government, Public Entity or an Organ of State must file the audited annual financial statement and annual report compiled in terms of 20 section 13G (1), with the Commission, in the prescribed FORM B-BBEE1 with thirty (30) days of the approval of such audited financial statements and annual report.

- 2.2 A compliance report required to include annually in terms of section 13G (1) of the Act from a sphere of Government, Public Entity or an Organ of State must be based on verified information as required by the Act, reflecting the state of compliance in respect of the following key elements of B-BBEE status.

- Management Control
- Skills Development
- Enterprise and Supplier Development
- Socio- Economic Development

3. DETAILED SCOPE OF WORK

3.1 Phase 1: Inception report

- Upon appointment the B-BBEE Verification Agency will be required to commence by drafting an inception report that will detail the overall B-BBEE Verification approach, methodology, expected timeframes and relevant costs for each phase of the project.
- The inception report will serve as a discussion document and will be the basis on which the detailed approach to the project is agreed.
- The inception report is an interim deliverable that is expected to be completed one week from the time that the B-BBEE Verification Agency is appointed.
- In agreement with COGTA identify the Project Steering Committee (PSC) and provide an indicative schedule for the PSC meetings.
- Securing permission to access verification information.

- The service provider will be required to present the first phase to the PSC for adoption.

3.2 Phase 2: Implementation

Capturing of B-BBEE Information

- The service provider will be required to capture B-BBEE information on data-capture sheets upon obtaining permission to access information.
- Analyze relevant information such as legislations, regulations and available research information.
- Analyze B-BBEE Verification claims, evidence and follow up on outstanding issues as per the technical guide.
- Produce B-BBEE verification report and scorecards for COGTA.
- Finalize COGTA B-BBEE reporting requirement with B-BBEE Commission
- Produce final B-BBEE Verification Certificates in line with the set standards.

3.3 Phase 3: Project Close out

Final report will be an integrated report from sub-reports compiled. This will also serve as a close out report which will be covering all the work done. The Service Provider will prepare a detailed closeout report and hand over the report on 4 hard copies and on electronic version to Cogta. In this phase the Service Provider is expected to produce the following
