The uMgungundlovu Economic Development Agency (UMEDA) seeks the services of reputable and qualified IT/ Telecommunications service providers for the **provision of 50Mbps Broadband solution and backup line at 20Mbps service for a period of 12 months.**

The specification is as follows:

- 50Mbps dedicated uncapped internet access on licensed microwave connection.
- Uninterruptible internet service, with minimum down-time with 20Mbps failover.
- Full installation/setup and testing of the internet line.
- Support centre(s) offering 24/7 support, including call logging procedures.
- High quality 1:1 local and international bandwidth.
- Availability:  $\geq 90.5\%$ .

Quotation documents will be evaluated using Responsiveness Criteria, Functionality and 80/20 of the PPPFA with its 2022 Regulations. A bidder that scores less than **42 points out of 60 (70%)** in respect of functionality will be regarded as submitting a non-responsive bid and will be disqualified.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim regarding preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
- (b) **“price”** means an amount of money tendered for goods or services and includes all applicable taxes less all unconditional discounts.
- (c) **“Rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes.
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“The Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
