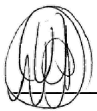

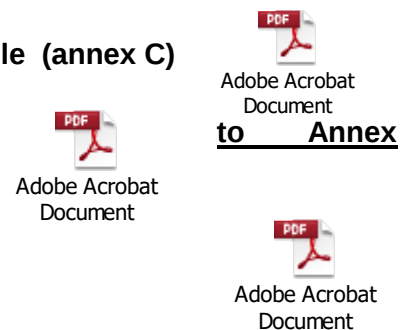

  - (e) forward the matter for criminal prosecution.
