1. INTRODUCTION

• INTRODUCTION TO THE MINE HEALTH AND SAFETY COUNCIL

The Mine Health and Safety Council (MHSC) is a national public entity (schedule 3A), established in terms of the Mine Health and Safety Act, No 29 of 1996, as amended. The MHSC is mandated to advise the Minister of Mineral Resources on Occupational Health and Safety (OHS) issues in the mining industry relating to the development and implementation of the MHSC annual OHS research programme, reviewing and development of mining OHS legislation and dissemination (knowledge and technology transfer) of MHSC research outcomes to improve OHS conditions in South African Mining Industry.

The appointment of qualified list of service providers will create a pool of qualified, above and below the line integrated marketing communications specialists to enable the MHSC be agile when responding to serious accidents and fatalities in the mining sector. The service providers will also help the entity proactive plan for campaigns geared at reducing the number of fatalities in the SAMI.



2. PART A: THE CONTRACT

- **CONTEXT OF THIS PROCUREMENT**

The MHSC seeks the services of experienced list of service providers to take full responsibility for the entity's below and above the line advertising, graphic designing and printing including brand activations across various platforms throughout South Africa. In the MHSC's case, integrated marketing communications (IMC) means the process of unifying the entity's messaging to make it consistent across various media that the MHSC uses to reach its intended target audience.

- **CONTRACT PERIOD**

The contract will be valid for a period of three (03) years.

- **TERMS OF REFERENCE**

2..1 DETAILED SPECIFICATIONS/SCOPE OF WORK

Proposals are invited from suitably qualified and experienced independent service providers who will originate, execute, and provide the following services on an "ad-hoc" basis for a valid period of three years (thirty-six months):

- a) Planning and execution of quarterly campaigns and brand activations
- b) Multiple short video creation/production and animations reflecting prevalent occupational health and safety (OHS) challenges in the SAMI.
- c) Creative posters for both printing (A1, 2, 3, 4, 5 format) and digital usage for social media platforms, online, such as website reflecting prevalent OHS challenges in the SAMI.
- d) Conceptualising, designing, layout and printing of The MHSC Annual Report, approximately 100 copies annually in full colour and submission of a digital master copy to the MHSC.

- e) Conceptualisation, layout and printing of MHSC promotional material such as guidelines, booklets, pamphlets, books and handbooks and magazines
- f) Conceptualise and build functional exhibition stand/booth with (electrical points, internet and television screens) if required to do so on behalf of the MHSC, based on the brief given by the MHSC.
- g) Media buying capabilities or placement of advertorials and advertising materials on magazines or any mass communication platforms.
- h) Conducting of quarterly digital campaigns and report on the reach, impact including impressions using analytics for each campaign executed.
- i) Development of creative printed cards, QR Codes associated with various MHSC campaign/ dissemination material for easy distribution and sharing with the SAMI.
- j) Overall branding including revising of the entity's corporate identity manual in line with the MHSC mandate.
- k) Creating internal profiles of the entity's planned activities, using email banners and screensavers as part of internal communication and marketing efforts to bridge communication gap.

The MHSC reserves the right to conduct supplier due diligence prior to final award or at any time during the contract period. This may include interviews, presentations and requests for additional information and samples where required.

3. PART B: THE PRICING

PRICING INSTRUCTIONS	
1.	Applicable currency: All prices shall be quoted in South African Rand (R).
2.	Completion of pricing schedule: Bidders shall complete the pricing schedule in full, inserting all the information required therein.
3.	Price Quotation Basis: total prices quoted must be inclusive of all applicable taxes including VAT, less all unconditional discounts, plus all costs to deliver the services and/or goods. Where imported goods/services are to be used, and pricing is subject to exchange rate fluctuations, the exchange currency against the Rand must be stipulated, as well as the exchange rate at the time of bidding. The portion of the bid price subject to exchange rate fluctuations must be stated.
4.	Submission of pricing: bidders must submit their pricing proposals with the technical proposal. The pricing folder must be clearly labelled as such.

- Bidders are to note that MHSC has an intention to appoint a list of service providers whereby services will be required on a recurring basis as and when the need arises.
- Bidders are not required to submit a detailed SBD 3 pricing quotation/offer for this bid, as the service providers will be selected through a functional/technical evaluation criterion and thereafter a presentation phase.
- The service providers will be appointed based on functionality and presentation evaluation criteria. All bidders that pass the minimum functionality and presentation phase threshold will become part of the list of service providers.



3.1 GUIDELINE ON THE UTILISATION OF THE LIST OF SERVICE PROVIDERS

- Once the list of service providers has been appointed, only the successful applicants will be approached on a rotational basis to submit quotes based on the rules stated in the terms of reference/scope of work. The 80/20 preferential procurement (preferential procurement regulations 2022) will apply whereby the specific goals will be applicable as and when MHSC implements the request for quotation.
- All costs associated with the bidder's proposal will be clearly specified upon requests for quotes when the need arises. New quotes, valid for 30 days, will be requested from the successful bidder(s) as and when items are required by the end users.
- The service provider will provide pricing as per the nature of the event to be organised when the request for quotation is sent to them in line with the scope of work.
- When quoting, the prices must be inclusive of all expenses, VAT (if VAT registered), delivery as well as all deliverables indicated in the scope of work.
- However, it should be noted that no guarantee is provided to any service provider that work will be allocated to them on a yearly basis once appointed. Products/services which will be required over the duration of the contract are dependent on circumstances which cannot be determined in advance.
- The service providers will be used on a rotational basis "as and when" the need arises.
- No deposit or advance payments shall be payable. Payments will be made in accordance with the PFMA (within 30 days of receipt of invoice after delivery of goods or services rendered).



4. PART C: BID SELECTION PROCESS

4.1 BID PREPARATION AND SUBMISSION

- 4.1.1 Number of bid documents: **1 X Original and 2 X copies** of the original for contract signing **(Hard copies) – THREE.**
- 4.1.2 Number of bid documents (Electronic Copy) of the original document in PDF **(USB) – ONE.**
- 4.1.3 Bid documents must contain both technical proposal and pricing proposal **(two envelope system).**

A digital version on USB/Memory stick containing the bid document and all other supporting documents (fully submitted bid proposal with its attachments) must be provided of all tender documentation within the bid envelope/pack. These serve as the sets of bid documents and form part of the contract.

4.2 BID CLOSING

- 4.2.1 There shall be no public opening by the MHSC of the bids received.
- 4.2.2 There shall be no discussions with any enterprise until evaluation and adjudication of the proposal has been complete.
- 4.2.3 Any subsequent discussions shall be at the discretion of MHSC. Unless specifically provided for in the proposal document, bids submitted by means of telegram, telex, facsimile or similar means shall not be considered by MHSC.
- 4.2.4 All bids shall close on the specified date and time as stipulated in the bid document.
- 4.2.5 Bids received after closing time and date will be classified as LATE and will not be considered.

4.2.6 Bids submitted in any other manner other than the specified address (tender box) shall not be accepted.

4.3 ADMINISTRATIVE COMPLIANCE (RETURNABLE DOCUMENTS)

Administrative compliance/responsiveness will be tested based on returnable documents submitted and signatures on the Bid documents.

At this stage the verification is to review bid responses for purposes of assessing compliance and governance with RFB requirements, whereby a bidder **will** be disqualified if they do not fully comply, it must be determined what documents are required to be returned by Bidders.

Bids will be verified for compliance with the procedural requirements of the bid, which entails the completion and/or submission of the returnable documents and schedules specified in the Returnable Documents and Schedules Checklist below. **No award will be done without complete provision of returnable documents and any schedules.**

4.4 MANDATORY COMPLIANCE – CENTRAL SUPPLIER DATABASE

Bidders are required to be registered on the Central Supplier Database (CSD) of National Treasury prior to submitting their bid (open tenders). Failure to being registered on the CSD and failure to submit the requested proof of registration on CSD information will lead to disqualification. (Please provide proof of registration on the Central Supplier Database).



Only suppliers who are registered with the Central Supplier Database (**CSD**) will be considered for this bid. Bidders who are not registered on CSD, will be disqualified.

4.5 MANDATORY COMPLIANCE – TAX STATUS VERIFICATION

Bidders are required to submit their tax compliance status with their bid in the form of a Tax Verification PIN from SARS or CSD supplier number which must be captured in the SBD 1. MHSC only conducts business with bidders whose tax matters are in order. Failure to comply in terms of tax obligations will render your bid non-responsive and disqualified. It is the responsibility of the bidder to ensure they are tax compliant at time of submitting their response.

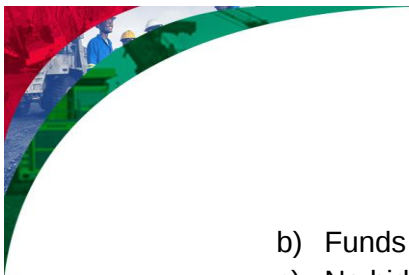

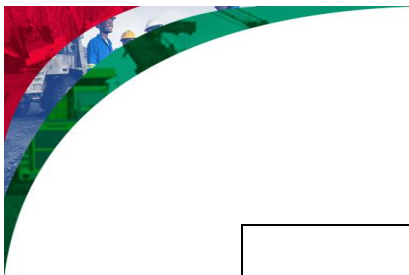

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

The Mine Health and Safety Council (MHSC) cannot amend the National Treasury’s General Conditions of Contract (GCC). The Mine Health and Safety Council (MHSC) appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.
