1. GENERAL / BACKGROUND

The Security Risk Management (SRM) is responsible to ensure protection of the SADPMR's Assets on 24 hours basis.

1.1 SCOPE OF SERVICE

Prospective suppliers must visit the site to ascertain the extent of service to be rendered. Site inspections must be arranged with the relevant appointed representative of SADPMR.
