## 1. BACKGROUND IZIKO

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 11 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

## 2. SCOPE OF WORK

We require a service provider to facilitate and coordinate 6 (six) community consultation meetings in Upington during 2025. This is part of an Iziko Museum Special Project and requires discretion and professional facilitation. The service will include arranging the attendance of up to 22 participants from various locations. All travel, event coordination, and associated procurement is required. This includes:

1. 2 (two) x flights for 2 people with one bag from Cape Town to Upington RETURN. Dates TBC but first flight will be for the March meeting.
2. 2 (two) x return airport transfers for 2 Cape Town based participants.
3. Transport for 19 participants to and from the venue in Upington) each month for the 6 month duration. Participants will be travelling from the outskirts of Upington and further afield, including regions close to the Kalahari (please see breakdown of areas below. All distances are measured from Upington). **Please consider local, cost effective transport and note that these localities may change slightly.**
  - Kalahari – Scotty’s Fort – X1 (300km)
  - Keimoes – X1 (40km)
  - Kakamas - X1 (83km)
  - Kuboes – X1 (600km)
  - Alexanderbaai - X1 (600km)
  - Okiep - X1 (380km)

  - Upington - X3
  - Platfontein - X2 (400km)
  - Kimberly - X2 (400km)
  - Campbell - X2 (300km)
  - Griekwastad - X2 (250km)
4. Accommodation for up to 22 people (**include breakfast, lunch and dinner**), single rooms, for each of the itemised events. We would like everyone to stay at the meeting venue. Please **do**

**not** consider Desert Palace Casino for these events. We have identified a date in March for the first event but the other 5 events will be monthly at a date to be confirmed.

- a. Check in - 23 March 2025; check out – 27 March 2025 for 22 participants. (4 nights)
  - b. 4 x meetings (April, May, June, July) for 19 participants. Dates TBC but will only be for 3 nights.
  - c. 1 x meeting (August) for 22 participants. Dates TBC but will be for 4 nights.
5. Meeting facility (air-conditioned) able to host up to 22 participants (as indicated above) for each monthly meeting from 9am to 5pm. The conference venue must include chairs, tables, pens and notepads.
- Venue must include some table sweets and water for all participants.
  - No audiovisual requirements except for the meeting day of 25 March 2025 (projector/screen required).
  - Venue must have a smoking section.
6. Stipend provisions are to be arranged and managed by the service provider for 19 participants. This includes SARS daily rates (R548.00) for all **travel and meeting attendance days**. If including this stipend exceeds allocated budget, it may be removed from the bid.

7. Contingency of 10% to cover any unforeseen requirements for the events or travel. This contingency is at the discretion of Iziko Museums.

Please note that these arrangements may change somewhat i.e. regions of collection, but all will be discussed with the service provider on appointment.

### 3. EVALUATION PROCESS

#### 3.1 Evaluation of Quotation

The contract shall be awarded at the sole and absolute discretion of Iziko. Iziko hereby represents that it is not obliged to award this quotation to any bidder. Iziko is entitled to **retract** this quotation at any time as from the date of issue or reduce deliverables.

All quotations will be evaluated according to the criteria, weightings and threshold scores as Indicated in 5.2 below:

### 3.2 Evaluation Criteria

The selected service provider shall be required to indicate their capacity to deliver the services required by Iziko as per the requirements below. Bidders are required to achieve a score of 80 points to be considered for the SPECIFIC GOALS and Price evaluations.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

### 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method
