1. PURPOSE

The purpose of this request is to appoint a service provider to supply labour force and material for reactive maintenance in the Tsitsikamma Section of Garden Route National Park for a period of 12 months.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. SCOPE OF WORK

The Contractor shall provide a workforce **and supply necessary materials** to undertake general maintenance activities within Tsitsikamma National Park.

The scope includes all routine and ad-hoc maintenance work required to ensure the proper functioning and upkeep of park infrastructure and facilities, including buildings, offices, chalets, staff houses, and common areas.

1. The scope of works shall include, but not be limited to:
 - General building maintenance and repairs
 - Plumbing and minor electrical maintenance support
 - Carpentry and minor construction works
 - Grounds maintenance and upkeep of park facilities
 - Maintenance of tourist accommodation units, offices, and staff housing
 - Supply and installation of maintenance materials as required
 - Any other maintenance-related tasks as instructed by the Employer

2. MATERIAL SUPPLY REQUIREMENTS

- The Contractor shall be responsible for the procurement, supply, and delivery of all materials required to execute maintenance work.
- Materials may include, but are not limited to:
 - Plumbing fittings and consumables
 - Electrical components (minor works)
 - Timber, boards, and carpentry materials
 - Paints, sealants, and coatings
 - Fasteners, general hardware, and consumables
- All materials supplied shall be new, of good quality, and compliant with relevant South African standards.
- The Contractor shall ensure that materials are fit for purpose and suitable for coastal/environmental conditions within the park.

3. MARK-UP ON MATERIALS

- The Contractor shall apply a percentage mark-up (%) on the cost of materials supplied.
- The mark-up shall:
 - Cover procurement, storage, handling, and transport of materials
 - Include overheads and profit related to material supply
- The percentage mark-up must be clearly stated in the Bill of Quantities (BOQ).
- Payment for materials shall be based on:
 - Actual cost of materials (supported by invoices), plus
 - Approved mark-up percentage

4. WORKFORCE REQUIREMENTS

- 1 Site Supervisor
- 4 Skilled Workers (Carpenter, Plumber, Bricklayer, Welder)
- 2 Semi-Skilled Workers
- 2 General Workers

5. PPE REQUIREMENTS

- Contractor to provide:
 - Conti-suits
 - Safety boots
- SANParks will provide:
 - General PPE (gloves, goggles, etc.)
