Tenders are hereby invited for the Civil Works for 'LOBATLA WATER SUPPLY'.

Scope of Work includes

- Laying of bulk line of uPVC from boreholes to storage and laying of internal network consisting of uPVC pipes, pipe diameter 75mm to 110mm, total length of about 66,5km
- Equip and electrify two new boreholes
- Install 240 metered yard connections

Bids will be adjudicated based on the Preferential Procurement Regulations 2022 using compliance, functionality and 80/20 points system. The point system that will be applied is 80/20, relating to preference and price points respectively and as is fully described in the tender document.

Tenderers must have the necessary skills, experience and capacity to complete and commission the Works successfully in terms of the tender documents and to the required standards.

Tenderers must be registered with the CIDB and have a CIDB grading designated 7CE or higher
