DESCRIPTION: TRAVEL MANAGEMENT SERVICES

1. **Question:**

To submit a Joint Venture tender for 2 or more Travel Companies that is registered on the PetroSA portal - How do one submit the JV tender, must we choose 1 business and then include the JV agreement and the BEE certificate?

Answer:

The Joint Venture must be registered on National Treasury' Central Supplier Database, as its own registration and the registration must be completed on PetroSA website online as required.

NB: A joint venture should be registered on the CSD. The reason being, the contract entered is with the joint venture, which will have its own banking details, VAT obligations and B-BBEE information.

Kindly follow the guide below in order to register the joint venture on the CSD:

- Ø Log in on the CSD www.csd.gov.za
- Ø Click on Supplier Details
- Ø Click Add Supplier
- Ø On the Supplier Type, please select Unincorporated Body of Persons
- Ø On the Supplier Sub-type, please select Joint Venture
