STANDARD CONDITIONS OF TENDER (Goods / Services)

1. DEFINITIONS

General:

- (1) Defined words / phrases are printed in *Italic font*.
- (2) Definitions apply to the singular as well as the plural.
- (3) Any reference to the masculine gender shall be taken to include the feminine and any reference to the feminine gender shall be taken to include the masculine.
- (4) The words “bid” and “tender”, and “bidder” and “tenderer” can be used interchangeably.
- (5) All definitions as defined in the ***General Conditions of Contract*** are applicable to these ***Standard Conditions of Tender***. These definitions include:
 - “Closing time”
 - “Contract”
 - “Contract Price”
 - “Corrupt practice”
 - “Countervailing duties”
 - “Country of origin”
 - “Day”
 - “Delivery”

- (6) **Bid or Tender:** The offer submitted in respect of an invitation to submit such an offer.
- (7) **Bidder or Tenderer:** An entity (company, close corporation, partnership, joint venture, sole proprietor) which submits a *bid/tender*.
- (8) **Municipality:** The eThekweni Municipality, as represented by the duly authorised delegate, official or committee.
- (9) **SCT:** Special Conditions of Tender (found in Section 3).
- (10) **Week:** A period of seven (7) consecutive *days*.
- (11) **Material Deviation:** A material deviation or qualification is one which, in the *Municipality’s* opinion, would:
 - (a) Detrimentially affect the scope, quality, or performance of the services or supply identified in the Scope;
 - (b) Significantly change the *Municipality’s* or the *Tenderer’s* risks and responsibilities under the contract; or
 - (c) Affect the competitive position of other *Tenderers* presenting responsive *tenders*, if it were to be rectified.

2. CONDITIONS OF TENDER & CONTRACT

The specification will be governed by the ***Standard Conditions of Tender*** (Goods and Services), ***Special Conditions of Tender (SCT)***, ***General Conditions of Contract (GCC)*** (Government Procurement General Conditions (July 2010), as amended by National Treasury Circular 52 dated 30 July 2010), the ***Special Conditions of Contract (SCC)***, the ***Occupational Health and Safety Act*** (Act No. 85 of 1993), and the ***eThekweni Code of Conduct***.

Complete Acceptance of Conditions

Unless otherwise expressly stipulated in a letter covering the *tender*, every *Tenderer* shall be deemed to have waived, renounced, and abandoned any conditions printed or written upon any stationery used for the purpose of, or in connection with, the submission of their *tender*, which are in conflict with the ***General Conditions of Contract*** and ***Special Conditions of Contract***. *Tenderers* are advised that any *material divergences / qualifications* from the official Conditions or Specification will render their *tenders* liable to disqualification.

3. TENDER INFORMATION

- (1) **General**
 - (a) *Tenders* will be liable for rejection unless made out on the official tendering documentation.
 - (b) Any alterations effected upon any of the tendering documents must be clearly shown by means of a hand written (black, non-erasable ink), or typed, entry and must be signed in full by the *Tenderer*. **The use of correction fluid is not permitted.**
 - (c) *Tenderers* may submit alternative solutions that, in the *Tenderer’s* opinion, are to the *Municipality’s* advantage economically and technically. Full technical details of the alternative *tender(s)* shall be submitted with the tender documents. Alternative *tender(s)* shall be submitted separately.
- (2) **Obtaining Tender Documentation**
All tenders must be submitted on official tender documentation issued, in electronic format, by the eThekweni Municipality. Electronically downloaded documentation (obtainable free of charge) should be printed and suitably bound by tenderer.
- (3) **Queries Relating to this Tender**
Queries can be directed to the person / Department as stated in the ***SCT***.
- (4) **Briefing Session (Clarification Meeting)**
Details of the briefing session are stated in the ***SCT***. Failure to attend a **compulsory** briefing session will invalidate the *tender*. *Tenderers* must sign the attendance list in the name of the tendering entity. Tenders will only be evaluated from those tendering entities appearing on the attendance list.

(5) Closing Date and Delivery of Tender Submissions

Sealed *tenders* made out on the enclosed Official Tender Form, which shall be signed by or on behalf of the *Tenderer*, and addressed to the City Manager, marked with the appropriate Tender number, must be placed in the **Tender Box** as stated in the **SCT** not later than the **date and time** as stated in the **SCT**, where after they will be opened publicly.

All tender documents **must** be placed directly into the Tender Box and should not be delivered to any other Municipal Department. *Bidders* are advised that *tenders* submitted by post, fax or email **will not** be considered. All couriered documents must be placed directly into the Tender Box and should not be delivered to any other Municipal Department.

Any *tender* received after the closing date and time stated for the receipt thereof **shall not** be accepted for consideration and shall be returned to the *Tenderer*.

(6) Tender Validity and Withdrawal of Tenders

Tenders must hold good until 16:00 of the 5th week following the date on which *tenders* are opened, or during such other period as may be specified in the **SCT**. The *Municipality* may, during the period for which *tenders* are to remain open for acceptance, authorize a *Tenderer* to withdraw their *tender* in whole or in part on condition that the *Tenderer* pays to the *Municipality* on demand, a sum of one thousand Rand (R1,000.00). The *Municipality* may, if it thinks fit, waive payment of such sum in whole or in part.

4. RETURNABLE SCHEDULES, FORMS, CERTIFICATES

Each *Tenderer* shall complete fully and accurately the following documents and submit these documents with the *tender*:

- (1) **Authority of Signatory:** In terms of Clause 4(5)(c) of the Conditions of Tender.
- (2) **Tax Compliance Status PIN / Tax Clearance Certificate:** SARS has introduced a new Tax Compliance Status System. Tenderers can submit a Tax Compliance Status PIN (TCS PIN) instead of an original Tax Clearance Certificate. This TCS PIN can be used by third parties to certify the taxpayer's real-time compliance status.
- (3) **Declaration of Municipal Fees:** Only those *Bidders* whose municipal fees are fully paid, or those that have concluded acknowledgement of debt agreements with the *Municipality*, are eligible to *tender*.
All *Bidders* must sign the Declaration of Municipal Fees returnable form, declaring that their municipal fees are in order or that acknowledgement of debt agreements have been concluded, and include the relevant account numbers in the declaration. Failure to include account numbers or sign will invalidate the *tender*. The completion of the declaration is also applicable to *Bidders* outside of the eThekweni Municipal Area.
- (4) **Declaration with respect to the Occupational Health and Safety Act:** Acceptance of undertaking in terms of the Occupational Health and Safety Act (Act 85 of 1993) and the relevant Regulations.

(5) Municipal Bidding Documents (which includes):

- (a) **MBD 4: Declaration of Interest:** All *Bidders* are to sign the Declaration of Interest wherein they declare any relationship that may exist with an official of the Municipality involved in the evaluation process.
Regulation 44 of the Supply Chain Management Regulations states that a Municipality or Municipal Entity may not make any award to a person:
 - (i) Who is in the service of the state;
 - (ii) If that person is not a natural person, of which any Director, Manager, Principal, Shareholder or Stakeholder is a person in the service of the state; or
 - (iii) Who is an advisor or consultant contracted with the Municipality or municipal entity.
 Should a contract be awarded, and it is subsequently established that Regulation 44 has been breached, the Municipality shall have the right to terminate the contract with immediate effect.
- (b) **MBD 5: Declaration for Procurement Above R10 Million (if applicable):** For all procurement expected to exceed R10 million (all applicable taxes included), tenderers must complete this questionnaire.
- (c) **MBD 6.1: Preference Points Claim Form:** For the awarding of Preference Points, *Bidders* are required to complete the attached MBD 6.1 form and return it with their tender submission. Failure on the part of a tenderer to complete and submit this form will be interpreted to mean that preference points for **Specific Goals** are not claimed.
The Municipality reserves the right to require of a tenderer, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the Municipality.
- (d) **MBD 8: Declaration of Bidders Past Supply Chain Management Practices Form:** This form serves as a declaration to be used by municipalities and municipal entities in ensuring that when goods and services are being procured, all reasonable steps are taken to combat the abuse of the supply chain management system.
- (e) **MBD 9: Certificate of Independent Bid Determination:** Section 4(1)(b)(iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms if it involves collusive tendering or tender rigging. In order to give effect to this, the Certificate of Bid Determination must be completed and submitted with the tender.

(5) Official Tender Form (see Section 9)**(a) Legal Status of Tenderer**

It is essential for the purpose of entering into a legal contract that *Bidders* state on the Official Tender Form, under "Name and Address of Tenderer ", their full legal status:

- (i) the full registered name of the company making a *tender*; or
- (ii) if the *Tenderer* is a person conducting business under a recognised trading name then:
 - State the name of the person(s);
 - State recognised trading name; and
 - State whether an owner, co-owner, proprietor, etc.

(b) Signing of Official Tender Form

Failure of a *Tenderer* to complete, in its entirety, and sign the Official Tender Form will invalidate the *tender*.

(c) Authority of Signatory

Bidders are to complete and sign the Authority of Signatory returnable document, and attach the required additional documents.

(d) Differences or Discrepancies

Should there be any difference or discrepancy between the prices or price contained in the Official Tender Form and those contained in any covering letter from the *Tenderer*, the prices or price contained in the Official Tender Form shall prevail.

(6) Any additional Schedules, Forms, or Certificates as stated in the SCT.**5. INFORMATION TO BE SUPPLIED REGARDING SUB-CONTRACTORS**

Bidders are to state in their *tenders*, or covering letters, whether, if the contract were to be awarded to them, the whole of the work would be executed by them in their own workshop / factory. If the answer is in the negative, they are required to state which part(s) would be handed to sub-contractors and the name and address of such sub-contractors.

6. SAMPLES

Bidders may be required to state where samples of the full range of products can be inspected or be required to submit samples for inspection prior to the closing date of the *tender*.

7. MANUFACTURERS

The names of the manufacturers of the goods or equipment offered must be stated in the *tender*.

Bidders who are not manufacturers, accredited distributors, or agents must provide a valid agreement / Joint Venture Agreement, entered into with the manufacturer, accredited distributors, or agents, with their submission. This agreement must meet all the requirements as laid down in the *tender* document, and must cover the contract period.

8. CLARIFICATION

The Head: Supply Chain Management Unit, or an authorized representative, may request clarification or further information on any aspect of the *tender*. The *Tenderer must* supply the requested information within the time specified. Failure to comply will render the *tender* non-responsive.

9. PRICING

Bidders would be precluded from this *tender* if their pricing structure deviates from the Official Tender Form.

(1) Nett Prices

All prices shall be quoted in South African currency (Rand) after deduction of any brokerage or discount allowed to the Municipality.

(2) Unit Prices

Bidders shall quote only one price in respect of each item. Such price is to hold good for the full duration of the contract period, being subject to variation only in accordance with specified criteria, as stated in the *Conditions of Contract*.

(3) Firm Tenders

Bidders may submit firm prices for each 12 month period. These prices shall be free from all fluctuations, including any statutory increases.

(4) Value Added Tax (V.A.T)

Prices exclusive and inclusive of VAT must be stated separately on the Official Tender Form.

10. ESTIMATED QUANTITIES

The estimated quantities are set out in Section 8 : Bill of Quantities / Schedule of Rates/Activities which forms part of the official tender documents. The quantities are stated purely for the information of the *Bidders* and are in order to ascertain an estimated total contract price. The *Supplier* will, however, be bound to supply whatever quantity or quantities the *Municipality* may actually require, and may exceed, or be less than, the estimated quantities stated.

11. DELIVERY, RISK, PACKAGES, ETC

- (1) Unless otherwise provided, all goods are to be supplied only against the form of order issued by the *Municipality*.
- (2) *Bidders* shall quote a unit price which shall include delivery to the specified delivery point, as stated in the *SCT*.
- (3) The risk in all goods purchased by the *Municipality* under the contract shall remain with the *Supplier* until such goods shall have been duly delivered.
- (4) *Bidders* shall clearly state the period within which delivery will be made after receipt of the official order, as this may be material in the adjudication of the *tender*.

12. RATES OF EXCHANGE

- (1) Where the goods are imported the *Supplier* shall, within seven days of date of official Purchase Order, arrange through their bankers for the foreign commitment to be covered forward down to the Rand in order to fix the rate of exchange. The *Supplier* shall notify the *Municipality* as soon as possible thereafter regarding the rate which has been fixed on such forward exchange.

Any increase or decrease between the basic rate of exchange as at a date seven days prior to the date of closing of *tenders* and that existing at the date of establishment of the forward exchange cover within the period stipulated above shall be paid or deducted by the Municipality. Upon the failure of the *Supplier* to arrange forward exchange cover, the *Supplier* shall be liable should there be any increase in the basic rate of exchange occurring after the last mentioned date.

The bank charges incurred in obtaining the forward exchange cover shall be for the *Municipality's* account.

- (2) The *Supplier* shall on request:
- Submit documentary proof of the rate of exchange; and
 - When an adjustment is claimed in terms of this sub-clause, whether by the *Supplier* or the *Municipality*, submit documentary proof to the satisfaction of the Deputy City Manager: Treasury in respect of such claim.

13. IMPORT PERMITS

- (1) In order to minimise special importation, *Bidders* should, where possible, have recourse to local suppliers and / or manufacturers.
- (2) *Bidders* must state whether their *tender* is dependent upon the issue of a special import permit or whether they are able to supply the goods by making use of the import facilities available to them.
- (3) In the event of a tender being dependent upon the issue of a special import permit, application for such special import permit shall be made by the Tenderer, unless otherwise provided for in the *SCT*.

14. EVALUATION PROCESS

The procedure for evaluation of responsive Tender Offers will be in accordance with the eThekweni Municipality's current SCM Policy and the Preferential Procurement Policy Framework Act (5 of 2000), and the Preferential Procurement Policy Framework Act Regulations (November 2022).

Details of additional evaluation criteria, if applicable, are stated in the *SCT*.

Evaluation points for price and preference will only be calculated for *Bidders* who comply with the contractual and technical specification, and if applicable, have attained the minimum Functionality Score as stated in the *SCT*.

The evaluation process of responsive *tenders* will be as follows:

- Score each *tender* in respect of the financial offer made and preferences claimed (if any);
- Calculate the total number of evaluation points (T_{EV}) in accordance with the following formula:
 $T_{EV} = N_{FO} + N_P$ where: N_{FO} : is the number of evaluation points awarded for the financial offer; and N_P : is the number of evaluation points awarded for preferences claimed.
- Rank *tenders* from the highest number of evaluation points to the lowest.
- Recommend the *Tenderer* with the highest number of evaluation points for the award of the contract, unless there are compelling and justifiable reasons not to do so.
- Rescore and re-rank all *Bidders* should there be compelling and justifiable reasons not to recommend the *Tenderer* with the highest number of evaluation points, and recommend the *Tenderer* with the highest number of evaluation points, unless there are compelling and justifiable reasons not to do so, and the process set out in this sub-clause is repeated.

(1) Evaluation points awarded for the financial offer:

Reference is to be made to the Special Conditions of Tender (*SCT*), and returnable form 5(c) in Section 4.

INCOME-GENERATING CONTRACTS

The financial offer will be scored using the formula:

$$N_{FO} = W \left(1 + \frac{Pt - P_{max}}{P_{max}} \right)$$

GOODS and SERVICES

The financial offer will be scored using the formula:

$$N_{FO} = W \left(1 - \frac{Pt - P_{min}}{P_{min}} \right)$$

Where the value of W is:

- (a) **90** where the financial value inclusive of VAT of all responsive *tenders* received have a value in excess of R 50,000,000; OR
- 80** where the financial value inclusive of VAT of one or more responsive *tenders* offers have a value that equals or is less than R 50,000,000.
- It is unclear** (at the time of advertising) which of the two preference point systems applies. Either the 80/20 or 90/10 preference point system will apply, determined by the price offered by the lowest acceptable tender.

(b) **P_{max}** is the comparative offer of the most favourable comparative offer (highest acceptable tender).

15. BRIBERY AND COMMUNICATION WITH COUNCILLORS / OFFICIALS**(1) Bribery**

No *Tenderer* shall offer, promise or give to any person or person connected with a *tender* or the awarding of a contract, any gratuity, bonus or discount etc, in connection with the obtaining of a contract.

(2) Communication, Councillors and Officials

A *Tenderer* shall not in any way communicate with a member of the *Municipality* or with any official of the *Municipality* on a question affecting any contract for the supply of goods or for any work, undertaking or services which is the subject of a *tender* during the period between the closing date for receipt of *tenders* and the dispatch of the written notification of the *Municipality's* decision on the award of the contract; provided that a *Tenderer* shall not hereby be precluded:

- (a) At the request of the Head: SCM Unit, or an authorized representative, from furnishing him with additional information or with a sample or specimen for testing purposes or otherwise from giving a demonstration so as to enable the recommendation to the Bid Committee on the award of the contract to be formulated;
- (b) From obtaining from the Head : SCM Unit, or an authorised representative, information as to the date upon which the award of the contract is likely to be made, or, after the decision upon the award has been made by the *Municipality* or any Committee to which the *Municipality* has delegated its powers, information as to the nature of the decision or such information as was publicly disclosed at the opening of *tenders* or from submitting to the Accounting Officer in writing any communication relating to their *tender* or the award of the contract or a request for leave to withdraw their *tender*; and
- (c) Provided further that nothing contained herein shall be construed so as to prevent information being sought and obtained from an Official in regard to any decision taken at an open Municipal meeting, or any Committee to which the *Municipality* has delegated its powers.

A contravention of subsection (1) and / or (2), or an attempt to contravene such subsection, shall be reported to the Accounting Officer, who may on receipt of such report disqualify the *tender* of the *Tenderer* concerned.

16. NEGOTIATIONS WITH PREFERRED BIDDERS

The *Municipality* reserves the right to invoke Regulation 24 of Municipal Finance Management Act if required.

- (1) The Accounting Officer may negotiate the final terms of a contract with *Bidders* identified through a competitive tendering process as preferred *Bidders*, provided that such negotiation:
 - Does not allow any preferred *Tenderer* a second or unfair opportunity;
 - Is not to the detriment of any other *Tenderer* ; and
 - Does not lead to a higher price than the *tender* as submitted.
- (2) Minutes of such negotiations must be kept for record purposes.
- (3) Such negotiation may be delegated by the Accounting Officer.

17. CANCELLATION OF TENDER PROCESS

The municipality is entitled to cancel the tender at any time before the award of a tender and the decision to cancel the tender shall be published in the same manner in which the original tender invitation was advertised. The Municipality shall, in no way, be liable for any damages whatsoever, including, without limitation, damages for loss of profit, in any way connected with the cancellation of this bid.

18. ACCEPTANCE OF BID

- (1) The *Municipality* does not bind itself to accept the lowest or any *tender*, and reserves the right to accept the whole or any part of a *tender* to place orders.
- (2) The *Municipality* reserves the right to accept more than one technically and contractually compliant *tender* for part or the whole of the contract and to place orders on the price and availability.
- (3) *Bidders* shall not bind the *Municipality* to any minimum quantity per order.
- (4) The successful *Tenderer (s)* shall be bound to provide any quantities stipulated in the specification.
- (5) Tenders will only be accepted on condition that:
 - (a) The *tender* is signed by a person authorised to sign on behalf of the *Tenderer* .

1.4 Failure on the part of the tenderer to submit the required proof or documentation, in terms of the requirements in the (Special) Conditions of Tender for claiming **Specific Goal** preference points, will be interpreted that preference points for **Specific Goals** are not claimed.

1.5 The Municipality reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard of preferences, in any manner required by the Municipality.

2.0 DEFINITIONS

2.1 “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.

2.2 “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts.

2.3 “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes.

2.4 “**tender for income-generating contracts**” means a written offer in the form determined by Municipality in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the Municipality and a third party that produces revenue for the Municipality, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions.

2.5 “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3.0 FORMULA FOR CALCULATION OF PREFERENCE PRICE POINTS

3.1 PROCUREMENT OF GOODS AND SERVICES

- ¹ Includes price quotations, advertised competitive bids, limited bids and proposals.
- ² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.
- ³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

1. Definitions

The following terms shall be interpreted as indicated:

- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignee store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the goods are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad markets its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.

- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the goods covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price, which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 "Supplier" means the successful bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.
- 1.26 "Tort" means in breach of contract.
- 1.27 "Turnkey" means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.
- 1.28 "Written" or "in writing" means hand-written in ink or any form of electronic or mechanical writing.

2. Application

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services (excluding professional services related to the building and construction industry), sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific goods, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 Invitations to bid are usually published in locally distributed news media and on the municipality/municipal entity website.

4. Standards

- 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of contract documents and information inspection

- 5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent Rights

- 6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.
- 6.2 When a supplier developed documentation / projects for the municipality / municipal entity, the intellectual, copy and patent rights or ownership of such documents or projects will vest in the municipality / municipal entity.

7. Performance security

- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the [amount specified in SCC](#).
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
- (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque.
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, [unless otherwise specified](#).

8. Inspections, tests and analyses

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that goods to be produced or services to be rendered should at any stage be subject to inspections, tests and analyses, the bidder or contractor's premises shall be open, at all reasonable hours, for inspection by a representative of the purchaser or organization acting on behalf of the purchaser.

- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.

- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the goods to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.

- 8.5 Where the goods or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such goods or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.

- 8.6 Goods and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.

- 8.7 Any contract goods may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods, which do comply with the requirements of the contract. Failing such removal the rejected goods shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.

- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 22 of GCC.

9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.

- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, [including additional requirements](#), if any, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1 Delivery of the goods and arrangements for shipping and clearance obligations, shall be made by the supplier in accordance with the terms [specified in the contract](#).

11. Insurance

- 11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery [in the manner specified](#).

12. Transportation

- 12.1 Should a price other than an all-inclusive delivered price be required, [this shall be specified](#).

13. Incidental Services

13.1 The supplier may be required to provide any or all of the following services, [including additional services](#), if any:

- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
- (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
- (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

14.1 [As specified](#), the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and;
- (b) in the event of termination of production of the spare parts:
 - (i) advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, [unless specified otherwise](#).

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the supplier shall, [within the period specified](#) and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5 If the supplier, having been notified, fails to remedy the defect(s) [within the period specified](#), the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment

16.1 The method and conditions of payment to be made to the supplier under this contract [shall be specified](#).

16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract.

16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.

16.4 Payment will be made in Rand [unless otherwise stipulated](#).

17. Prices

17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any [price adjustments authorized](#) or in the purchaser's request for bid validity extension, as the case may be.

18. Variation orders

18.1 In cases where the estimated value of the envisaged changes in purchase does not vary more than 15% of the total value of the original contract, the contractor may be instructed to deliver the goods or render the services as such. In cases of measurable quantities, the contractor may be approached to reduce the unit price, and such offers may be accepted provided that there is no escalation in price.

19. Assignment

19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts

20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the supplier's performance

21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the [time schedule prescribed](#) by the purchaser in the contract.

21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.

21.3 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the goods are required, or the supplier's services are not readily available.

- 21.4 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.
- 21.5 Upon any delay beyond the delivery period in the case of a goods contract, the purchaser shall, without cancelling the contract, be entitled to purchase goods of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.
- 22. Penalties**
- 22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.
- 23. Termination for default**
- 23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
- if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
 - if the supplier fails to perform any other obligation(s) under the contract; or
 - if the supplier, in the judgement of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner, as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.
- 23.5 Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchaser actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
- the name and address of the supplier and / or person restricted by the purchaser;
 - the date of commencement of the restriction
 - the period of restriction; and
 - the reasons for the restriction.
- These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.
- 23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.
- 24. Antidumping and countervailing duties and rights**
- 24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the supplier to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the supplier in regard to goods or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.
- 25. Force Majeure**
- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.
- 26. Termination for insolvency**
- 26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to the purchaser.

27. Settlement of Disputes

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Notwithstanding any reference to mediation and/or court proceedings herein,
- (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 - (b) the purchaser shall pay the supplier any monies due the supplier for goods delivered and / or services rendered according to the prescripts of the contract.

28. Limitation of Liability

- 28.1 Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6;
- (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
 - (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

29. Governing language

- 29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

30. Applicable law

- 30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.

31. Notices

- 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. Taxes and duties

- 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid SARS must have certified that the tax matters of the preferred bidder are in order.
- 32.4 No contract shall be concluded with any bidder whose municipal rates and taxes and municipal services charges are in arrears.

33. Transfer of Contracts

- 33.1 The contractor shall not abandon, transfer, cede assign or sublet a contract or part thereof without the written permission of the purchaser.

34. Amendment of contracts

- 34.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.

35. Prohibition of restrictive practices

- 35.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is / are or a contractor(s) was / were involved in collusive bidding.
- 35.2 If a bidder(s) or contractor(s) based on reasonable grounds or evidence obtained by the purchaser has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in section 59 of the Competition Act No 89 Of 1998.
- 35.3 If a bidder(s) or contractor(s) has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.

SCC 11.1 INSURANCE

It is the sole responsibility of the service provider to maintain insurance cover to the value of R 10,000,000.00 to cover eThekweni Municipality against all insurable risks for the duration of this contract

SCC 12.1 TRANSPORTATION

The bidder would need to comply with all the Road Traffic Management regulations when driving municipal vehicles. All traffic fines obtained during this transit period would be for the successful bidder's account.

SCC 14.1 INCIDENTAL SERVICES

The bidder would be required to render services according to the need of the operations as specified by the eThekweni Municipality

SCC 14.1 ORIGINAL PARTS

The bidder must carry adequate original parts inventory that is required to perform the repairs and maintenance.

SCC 15.4 WARRANTY – NEW COMPONENTS/ORIGINAL PARTS/REMANUFACTURED

All new and remanufactured components must carry a minimum warranty of twelve (12) months.

SCC 15.5 WARRANTY

All original parts as stipulated in SCC15.4 and found to be defective must be replaced within forty-eight (48) hours from time of notification.

SCC15.6 WARRANTY- WORKMANSHIP

All repairs must carry a minimum warranty of twelve (12) months.

SCC 16.1 PAYMENT

The Contractor shall submit to the Department concerned a detailed account which shall reflect the identifying number of each item / service. Payment will be made on this account when checked and substantiated by the authorised official.

Payment for goods received and accepted by the Municipality shall be made no later than 30 days after submission of invoice or claim, provided however that all the terms of the contract are duly complied with.

Payment will be made only to the supplier. Factoring arrangements will not be accepted.

SCC 17 PRICES**COST PER KILOMETRE**

The cost per kilometre rates be fixed for the duration of the contract.

Labour

Prices for labour will be fixed for the first twelve (12) months of the contract, thereafter Application / requests for price adjustments will be allowed annually to cover year two (02) and year three (03), these must be in line with the Motor Industry Bargaining Council (MIBCO) increases.

The application / request for price adjustment must be addressed via a signed formal letter (on the service providers company letterhead) to City Fleet Contracts Department. The letter must be accompanied by relevant supporting documents such as Bargaining Council labour increase. circulars/ notices and schedules.

The new prices (year 2 and 3) will only be implemented once the internal approvals of the adjustment requests have been finalised and such will be communicated to the service provider

SCC 21.1 DELAYS IN THE SUPPLIER'S PERFORMANCE**BUSES**

- Attendance and recovery of breakdowns- must be within two (2) hours from the first call.
- Safety Inspection (Interior & Exterior) - must be carried out within one (1) day from date the bus is referred to the workshop.
- Preparation for Certificate of Roadworthiness (COR) - must ensure that a bus is prepared and ready for Certificate of Roadworthiness (COR) testing within (5) days from date the bus is referred to the workshop.
- Engine removal, replacements and commissioning - should be completed within ten (10) days.
- Transmission replacement - transmission fitments must be completed within five (5) days from date the bus is referred to the workshop.

SCC 22.1 PENALTIES FOR BUSES

ADDITIONAL CONDITIONS OF CONTRACT**ACC1 PERFORMANCE MONITORING & ASSESSMENT OF SERVICE PROVIDERS**

For contract awards that are greater than R10m, the Contractor shall be subjected to “Performance Monitoring” assessments in terms of the applicable Section of the Council’s current Supply Chain Management Policy.

ACC2 **QUALITY OF PRODUCTS**

No inferior products will be accepted under this enquiry.

All work to be conducted in this contract must comply with SABS standard but not limited to the following below

1. SANS 10253 of 2005, SABS 10257 - Brake service workshops, reconditioning of valves for use with pipelines.
2. SABS 0166/SANS 10166 - overhaul of diesel fuel injection equipment.
3. SANS 20090 - Replacement brake lining assemblies and drum brake linings for power driven vehicles and their trailers.
4. SANS 10256 - Brake drum reconditioning
5. ISO 9001 - Quality Management System.

Should there be any cause for complaint against the standard of service or quality of products offered which is not resolved within a period of 10 working days, the Municipality reserves the right to cancel the contract after serving one month’s notice, in writing, to the supplier involved. Should such notice be given, the supplier shall nevertheless be obliged to perform the duties covered by the contract up to the date of expiration of the period of notice.

ACC3 **SATISFACTORY PERFORMANCE**

The supplier shall employ for the purpose of this contract only such personnel as are careful and competent and the Municipality shall be at liberty to object to and require the supplier to remove from the job forthwith any person, including supervisory staff, employed by the supplier who, in the opinion of the Municipality, misconducts himself/herself or is incompetent or negligent in the proper performance of his/her duties and such person shall not again be employed upon this contract without the permission of the Municipality.

ACC4 **OCCUPATIONAL INJURIES AND DISEASES ACT**

This act replaces the Workmen’s Compensation Act:

The supplier shall, before commencement of work, produce documentary proof to the Deputy Municipal Manager, Treasury: Finance that he has complied in all respects with the provisions of the Occupational Injuries and Diseases Act. The supplier undertakes that he/she will perform and comply with all provisions of the Occupational Injuries and Diseases Act and more particularly that he/she will render all returns and pay all assessments for which he/she is liable in terms of such Act.

ACC5 DAMAGE TO PERSONS AND PROPERTY

- (1) The supplier **shall** indemnify and keep indemnified the Council against any claim for death, injury, damage or loss to any person or property whatsoever in respect thereof or in relation thereto.
- (2) The supplier enters into this contract as an independent contractor and shall be solely liable in respect of any claim for death, injury, damage or loss to any person or property whatsoever in respect thereof or in relation thereto.

ACC6 RATE OF EXCHANGE VARIATION

Where the goods are imported the Contractor shall within seven days of date of Official Purchase Order, arrange through his bankers for the foreign commitment to be covered forward down to the Rand in order to fix the rate of exchange. The Contractor shall notify the Municipality as soon as possible thereafter regarding the rate which has been fixed on such forward exchange. The forward cover shall be from a reputable South African bank. The Contractor is to confirm with the employer prior to placing forward cover if the service provider is acceptable.

Any increase or decrease between the basic rate of exchange as at 12:00 on the date of close of the bid and that existing at the date of establishment of the forward exchange cover within the period stipulated above shall be paid or deducted by the Municipality. Upon the failure of the Contractor to arrange forward exchange cover, the Contractor shall be liable should there be an increase in the basic rate of exchange occurring after the last-mentioned date.

The bank charges incurred in obtaining the forward exchange cover must be included in the Tenderer's bid.

ACC7 ESTIMATED QUANTITIES

The quantities stated in Section 8 are applicable for evaluation purposes only. The final quantity of goods and services required shall vary, depending on the total number of actual instances service/goods will be required over the Contract Period. The rates tendered shall be applicable, irrespective of the total quantity of goods and services procured over the contract duration.

ACC8 SERVICE PROVIDER OFFICE REQUIREMENTS

The service provider must have, for the duration of the contract, a local presence within the geographical eThekweni boundary.

SERVICE INTERVALS

To make the Vehicle available for the Work to be performed thereon to the BIDDER timeously; to make payment to the Bidder for the Work as per the agreed rate; to ensure that the instructions for the use of the Vehicle contained in the Owner's Manual for the Vehicle are carried out; that if any defect or failure occurs in the Vehicle, the Municipality will take all reasonable measures to mitigate the damage, and to minimize the occurrence of any consequential damage; save as otherwise provided, the Municipality shall ensure that licensed drivers operate the Vehicle; to permit the Bidder to inspect and check at any times the odometer, and any other instrument measuring distance travelled by the Vehicle; to utilize the Vehicle within the ambit of its application as a commuter bus; to ensure that the Bidder attends to a Vehicle that requires engine oil top up, and such top ups will be for the account of the Bidder, notwithstanding that such fluid top ups are the responsibility of the Bidder which should be performed during periodic servicing and maintenance; shall advise the Bidder whenever the Vehicle is taken out of service for any period

exceeding two weeks and when it is returned into service;

The Municipality shall as soon as practicable inform the Bidder immediately in writing of any sale of the Vehicle, any other permanent changes in the control or possession of the Vehicle, the destruction of the Vehicle or its final laying up or a laying up which lasts more than **6 (SIX)** months; in the event of a change by the Municipality of registration numbers on the Vehicle, the Municipality must notify the Bidder in writing as soon as possible thereafter.

ACC13 **Service Provider Obligations**

- a. Shall ensure that all the Work is undertaken with the reasonable level of care and skill that is expected of the Service Provider, but not less than what the OEM currently practices in its own business operation.
- b. Shall ensure that all their staff or agents are properly qualified artisans and are sufficiently trained in the specific models of Vehicles being worked on and that they have bus technical experience;
- c. Shall ensure that the workshop equipment is kept and maintained to its original state or condition and to ensure a periodic servicing and maintenance of the mentioned said equipment as set out in clause 11. 3 hereof.
- d. Shall ensure further that all staff complies with all health and safety requirements in terms of the Occupations Health and Safety Act, as amended and any further legislation applicable at the time;
- e. Shall ensure that the Work is performed timeously and without delay and in accordance with the Operator's requirements to ensure maximum bus availability during peak times
- f. Understands that all obligations imposed on it shall also apply to any agent of the Bidder equally to which the Bidder is jointly and severally liable.
- g. Shall be liable for all costs or damages sustained by the Municipality as a result of a failure by the Service Provider to fulfil its obligations in terms of this Agreement or as a result of OEM's or Service Provider negligence in performing its obligations; is aware and accepts that the Municipality has a standardized electronic vehicle monitoring system, which is fitted to all vehicles that form part of this contract. The service provider shall ensure that it shall not in any way cause any disruption to the aforesaid system or any new system that might be installed in future.
- h. To maintain valid accreditation/certification for the duration of the contract.
- i. To provide the Municipality with a detailed organogram of its staff structure that will be attending to the Work.
- j. The OEM is made aware that the operation of the bus service will be undertaken by a chosen Operator and the Bidder is always obliged to interact with and always cooperate with the Operator.
- k. All Bidder staff must be identified by properly dedicated uniforms and identification cards.
- l. the service provider is obliged to always ensure the proper functioning of the odometer as this is crucial to the proper calculation of the monthly distance travelled.

- m. The Service Provider is obliged to monitor and manage staff and productivity levels for the performance of Work in terms of this Agreement on principles no less onerous than the OEM's own business practices.
 - n. The OEM is to ensure that all Vehicles are properly and clearly identified with the name of the OEM printed thereon.
 - o. The Service Provider is obliged to take out adequate insurance to cover all of its functions and activities.
 - p. The OEM is to ensure that all Vehicles are properly and clearly identified with the name of the OEM printed thereon.
 - q. The OEM or Service Provider is obliged to take out adequate insurance to cover all of its functions and activities.
 - r. The contract shall provide all equipment, facilities, personnel, and other resources as are necessary and incidental to the due performance and execution of its obligations arising out of this tender.
 - s. The contractor shall receive and process instructions from eThekweni Municipality within the allocated time periods.
 - t. Provide the service in strict compliance with all applicable laws.
 - u. Refrain from any practice which may reflect adversely on the public image of eThekweni Municipality.
 - v. At its own cost, obtain all necessary licenses and registrations from the relevant competent authorities to enable it to provide the service.
 - w. The contractor shall guarantee a priority service to eThekweni Municipality, which shall take precedence over any other services that it may be involved in at the time.
 - x. The contractor shall within the allocated time periods deliver the required quotations; in whatever means nominated by eThekweni Municipality.
 - y. The contractor will daily provide eThekweni Municipality and their nominated representative a Work-in-progress report of all eThekweni vehicles at their premises.
 - z. The contractor is bound to allow eThekweni Municipality staff and all the representative free and uninhibited excess to all eThekweni vehicles on their premises with the view to inspect, assess etc.
 - aa. The contractor shall complete the workmanship within the time allocated for same, which is a pre-determined number of days.
 - bb. THE "PRIVATE" USE OF MUNICIPAL VEHICLES IS STRICTLY PROHIBITED
 - cc. The Contractor will be liable for all costs related to the tampering of Auxiliary equipment such as bar lights, vehicle tracking and fuel systems
 - dd. The bidder shall provide diagnostic software equipment (CAT) including the license and software update to eThekweni municipality Management which will be utilized at each work site by eThekweni officials.

ACC14 RECONCILIATION (FOR CPK CONTRACTS ONLY)**Actual exceeds anticipated kilometres**

If at any time during the contract period the actual kilometres travelled by the Vehicle exceeds the average kilometres travelled over a six-month period, then and in either event (or in both events), the parties can meet and negotiate the CPK rate.

Actual less than anticipated kilometres

If during any six-month period of this contract, the Vehicle travels less than 85% of the anticipated kilometres per month, the parties can meet and negotiate the CPK rate.

ACC 15 ANCILARY VEHICLHLE SUPPORT TEAMS

The service provider is required to have a minimum of four (04) fully equipped support vehicles for the duration of the contract. These vehicles will be first line of assistance on the road in the event of breakdowns and must cover all zones within the specified timelines.

ACC 16 CITY FLEET BUS OPERATIONS REQUIREMENTS

The section below provides details on Bus Operations requirements.

Due to the nature of public transport service, it is expected that a successful bidder would be required to render services as follows: Provide and deploy qualified mechanics to various Bus depot, Monday to Friday from 05h00 to 22h00 and on Saturday, Sunday and Public Holidays, from 06h00 to 20h00.

This deployment excludes standby staffing who are required to perform breakdown support.

The successful bidder would be required to perform outside the above stipulated operational hours, as and when required.

The tenderer must have service representation in South Africa and preferably in the eThekwini Municipal area that can provide original parts for the unit tendered on.

ACC17 PURCHASE OF GOODS FROM OTHER SOURCES

Nothing contained in this contract shall be held to restrain the Municipality from purchasing from persons other than the contractor, any of the goods described or referred to in this contract, if it shall in its discretion think fit to do so.

ACC18 STOCK HOLDING : CONSIGNMENT (IMPREST) STOCK REQUIREMENTS.

Service provider is required to provide the consignment stock that will be within the premises of the eThekwini municipality to ensure the quick turnaround times for the repairs and maintenance of the vehicles.

Conditions of consignment stock within eThekwini municipality premises:

- a) Stock to remain property of the service provider until issued/used by eThekweni municipality.
- b) **Service provider is responsible for:**
 - Service provider to submit min/max stock lists
 - Check Stock levels and replenishment
 - Shelf management
 - Labelling and identification
 - Stock rotation on "First in First Out (FIFO) basis.
 - Stock review frequency
 - Provision of monthly reporting.
 - Allocation of a dedicated support staff.
 - Supply of guaranteed OEM genuine/approved parts
- c) **eThekweni municipality is responsible for:**
 - Provide and secure storage area for the consignment stock allocation.
 - Access control for the service provider.
 - Monthly stock verification with service provider
- d) City Fleet and the bidder must enter into an agreement in terms of consignment stock.

ACC19 **VEHICLE MONITORING SYSTEM**

- a. All eThekweni Municipality vehicles including buses are monitored by the City Fleet Vehicle Monitoring Service Centre.
- b. All eThekweni vehicles require a Touch Key to start. All contractors must apply for a Touch Key to the Vehicle Monitoring Service Centre.
- c. Contractors must comply to all terms; conditions and procedures relating to the Touch Key.
- d. This encompasses but is not limited to the necessary paperwork, licensing requirements and AARTO regulations etc.
- e. Compliance thereto shall be the sole obligation of the contractor in respect of their staff competencies.

ACC20 **INFORMATION SHARING**

During the life of the contract the bidder will be obliged to communicate all information relating to the products including developments and amendments in product standards. The bidder will also be required to offer product orientation, diagrams and fitment demonstration for items that will be bought as stock items and fitted by the artisans at the workshops.

Provision of MAN trained technicians to upskill eThekweni municipality artisan as and when required.

ACC21 **REPORTS AND MEETINGS**

It is a requirement that the contractor attends any liaison meetings called by eThekweni Municipality and present any report requested of this contract.

CC22 **DRIVERS LICENCE**

The bidder shall ensure that its nominated employee has the necessary and applicable unendorsed coded licence to drive the said vehicle in the respective classes.

ACC23 STAFFING

Consignment stock controlling staff will be determined with the service provider upon contract award.

ACC 24 SKILLS DEVELOPMENT

The following disciplines will be considered as part of the skills development for this contract.

The successful bidder will be required to induct and train a minimum of two (2) apprentices for the duration of the contract, fifty percent (50%) of which should be Mechanical – Diesel orientation and other fifty percent (50%) should be Auto-Electrical.

Recruitment process

The successful bidder will be required to recruit the apprentices that have completed their N3 qualifications from a recognised SAQA accredited technical institutions.

The recruitment process must be fair, transparent and comply with best industry practices.

A City Fleet official must be present through the recruitment and appointment process on advisory basis.

Employment Equity

The successful bidder will be required to comply with the Employment Equity Act and the demographics when recruiting prospective candidates. Preference must be given to women or people living with disability.

It is important that the recruitment systems of the bidder be in line with EM recruitment policies that give preference to previously disadvantaged groups.

Minimum Remuneration

A bidder is expected to comply with a minimum industry wage which is stipulated to the industry standards or gazette.

General**Performance monitoring/meetings**

Quarterly performance reports must be presented and discussed with City Fleet.

The Training Programme

Successful bidder must submit together with their tender document, a detailed apprenticeship training programme. The training programme must cover a full product range as supported by the OEM.

Reserve the right to employ

The EThekwini municipality operates several mechanical workshops and employs a large workforce of mechanical artisans through its City Fleet Unit. On this basis the EM reserves the right to employ the qualified apprentices through this program which will have to comply with the EM recruitment practices.

Notwithstanding the above, it must be noted that all apprentices that have qualified on this programme are not guaranteed employment by the EM.

7.1 Unless otherwise specified in this Agreement, the bidder shall undertake the following Work:

All maintenance Work in accordance with the Bus Manufacturer's maintenance program (OEM standard) or Manuals which includes the supply of all parts, consumables (e.g. engine oils, transmission fluids, brake fluids, batteries, anti-freeze for cooling and heating installations, oil filters, wheel studs, Head lights bulbs replacement including all bulbs, fuel filters, gaskets, other lubricants including all top ups oils and service products etc.) and labour with the proviso that all top-up oils will be inclusive as part of the checks performed by the OEM or BIDDER;

7.2 All maintenance and repairs as a result of wear and tear in the normal use of the Vehicle.

7.3 All workshop and road tests specified by the OEM or by the Manufacturer for the purpose of servicing, inspection, diagnosis, repair and calibration of the Vehicle, in force on the commencement date of this agreement, and during the contract period;

7.4 Any faults diagnosed outside of these parameters(excluding accident damages) must be communicated to City Fleet personnel, via a technical failure report, quotation and must be approved by City Fleet, before the repairs are carried out.

-
- 7.5 All drive train repairs becoming necessary as a result of wear and tear in the normal use of the Vehicle; The successful bidder is expected to carry a swing stock unit such as Engines, Transmissions and Differentials specific to the chassis derivate.
- 7.6 The attendance at any breakdown and the subsequent towing of any Vehicle to any workshop, if required.
- 7.7 The performance of any preventative treatment checks or other work which the Vehicle manufacturer deems necessary.
- 7.8 Steam cleaning of the Vehicle prior to service/inspection, including washing of chassis, engine, gearbox, front and rear axle at the time of carrying out routine service and maintenance Work, including cleaning up in the vicinity of the service and maintenance work area.
- 7.9 To report on any visual defects, as soon as possible after detection thereon, on bodywork and tyres notwithstanding the fact that such Work thereon is not the specific responsibility of the OEM or Bidder; and
- 7.10 It is a requirement that the bidder undertake an inspection of the Vehicle at least every two weeks in order to determine any maintenance or repairs that may be necessary thereon, and in fulfilment of this requirement, is to provide the Municipality with a detailed check- sheet of what the inspection entails.
- 7.11 Rectification of damage caused to the vehicle or any part thereof by any act or omission or default of the third party including any failure to operate the vehicle in accordance with a Manufacturer.
- 7.12 Servicing and repair to standard equipment, spotlights as well as the use in the vehicle of parts, oils and other service-related products that is approved by OEM.
- 7.13 Repair to wipers, equipment, parts or accessories, installation which is approved by industry regulator;
- 7.14 Washing, care of paintwork and cosmetic repairs cleaning as well as repair to fuel system and injection equipment caused by dirty fuel or waxing
- 7.15 Repair or replacement of electrical components in accordance with OEM's specifications, early battery failure.
- 7.16 Repair or replacement of head lights, taillights, and the replacement of any electrical light globes;
- 7.17 Daily top-ups oils, lubricants, coolants, Ad-Blue as specified by the OEM.
- 7.18 Modifications required as a result of any changes in South African law after the commencement date of this agreement and renegotiate the cost with OEM.
- 7.19 Liable for any costs which are direct result of any failure to have the vehicle maintained timeously or failure to carry out preventative maintenance.
- 7.20 Repairs to or maintenance of any air conditioning/force draft unit in the vehicle and any components relating to any such unit.
- 7.21 Repairs to or maintenance of the tachograph of the vehicle.
- 7.22 Repairs to or maintenance of any radio, electrical or electronic devices and electronic destination not manufactured or supplied by OEM.
- 7.23 Recharge and replacement or repair of the battery/ies in the vehicle whenever such repair or replacement is required.
-

- 7.24 Maintenance of power take-off and related hydraulic, electronic equipment and wheelchair ramp.
- 7.25 A successful bidder shall be liable to EM for any repair or maintenance work or servicing carried out in respect of the vehicle and in such event, the EM shall claim against the bidder in terms of any warranty.
- 7.26 A clean bill of health should be conducted after accident repairs or repairs to any major mechanical/electrical work where the vehicle was out of commission for more than two (2) weeks at no additional cost. Brake test to be carried out pre- and post-accident repair.

8 ACCIDENTAL DAMAGE

The Municipality shall in a reasonable time notify the Bidder in the event that any Vehicle is involved in a collision or accident.

The Municipality shall have all damage caused to the Vehicle chassis by any collision or accident repaired by a workshop approved by OEM.

The costs of all repair work to be undertaken as a result of such accident or collision shall be borne solely by the Municipality unless such repair work was necessitated as a result of any act/omission by the Bidder.

If a situation arises where a Vehicle is in need of necessary repairs of a minor and/or emergency nature and a third party undertakes such repairs, then and in that event, the Municipality shall not require the OEM's consent, provided that the OEM is notified of such repairs within a reasonable time thereafter.

9 SERVICES OUTSIDE THIS AGREEMENT

Any servicing, maintenance and/or repairs carried out or undertaken by or on behalf of the OEM and falling outside the obligations of the OEM in terms hereof shall be charged by the OEM at a rate agreed to with the Municipality before undertaking the repairs and paid within **30 (THIRTY)** working days from the date of receipt of the invoice.

10 PROCEDURES FOR WORK

The BIDDER shall undertake the Work timeously and professionally.

The Municipality shall make the Vehicle available to the Bidder timeously for the Work to be performed on the Vehicle, and in any event, not more than 2 000 kilometers after the relevant service interval in the Service Booklet relating to the Vehicle concerned and, as and when reasonably required by the Bidder for the performance of any preventative treatment or checks thereon.

Other than for repair or replacement following a breakdown or major component failure all Work shall be completed on the day upon which the Municipality makes the Vehicles available for the Work unless the parties jointly agree that the required Work specifically requires a longer period for completion.

In order to ensure maximum availability of the fleet (and in the event of major component failure) the Bidder shall be obliged to have immediately available a replacement of all major service exchange stock components, such as engine, transmission, differential etc.

11 PLACES OF WORK

The Work shall be performed at of the Municipality's bus depots, namely Alice Street(Central), Ntuzuma, Umlazi and Rosburgh. The successful bidder will be required to set up the workshop and have team

readily available to assume work upon the award of the contract.

The Municipality shall bear the cost of rent, lights and water.

The Municipality shall provide the workshop equipment which includes but not limited to the following: compressed air and its accessories, brake testing equipment and its accessories, Hydraulic pit jacks and its accessories in the designated Workshop premises. The Bidder is to provide its own telephone, fax and computer requirements and all costs related thereto at its own expense. The Bidder shall bear the cost of any loss or damage occasioned to the property as a result of any act or omission on the part of the Bidder.

The Municipality shall be completely indemnified for any loss suffered to the Bidder and without limiting the generality hereof to:

- Injuries arising out of the use of any equipment, lubrication or any other agent.
- Any loss or damage suffered consequently or otherwise to the BIDDER or any third party.
- To any injury suffered, in any manner whatsoever to any staff or third party on the premises; and
- To any loss suffered by the BIDDER or any third party of any assets or equipment.
- Whilst it shall be the responsibility of the Municipality to clean the common the area of the depots it shall be the specific responsibility of the BIDDER to ensure that the area which it occupies is properly washed and always cleaned and kept in a presentable way.

12.2 **SCOPE OF CONTRACT**

The successful bidder will be required to provide the following services as well as other services that are implied or stated in this tender document, which include and are not limited to:

- a) Supply and delivery of spares to all workshops and stores.
- b) Provision of off-site service, maintenance and repair services.
- c) Collection and delivery of vehicles under contract.
- d) Inform S.C.M and workshop official timeously of the delays experienced in respect of the repairs being carried out i.e. backorder on parts etc. and provide the relevant proof from the vehicle manufacturer of the expected time of arrival of backorder spares.
- e) Strip and Quote within four (4) hours of receipt of vehicle.
- f) Adhere to the allocated dates for repairs.
- g) Adhere to all eThekwini rules; regulations and procedures as specified by the SCM and workshops.
- h) Ensure eThekwini vehicles are delivered back to the depot within two (2) working hours of completion together with invoices and supporting documents.
- i) Hold within eThekwini municipal area all service spares and fast-moving repair spares.
- j) The successful bidder will be compelled to comply with the procedures detailed in the technical specification including any amendments thereof.

13. Additional requirements

13.1 Air Systems / Pneumatic (Airbrakes)

The service provider will be required to perform the following:

- Reconditioning of valves for use with pipelines must comply with SABS 10257
- The facility that will conduct the above services must comply with SANS 10253 of 2005

13.15 Towing and Recovery Services

The service provider will be required to perform the following:

- The recovery/salvage of eThekwini vehicles on an as and when basis.
- Towing/Transportation of eThekwini vehicles, which means the provision of the tow truck services in response to despatch or request from the assessor/investigator or official of eThekwini Municipality for the moving or removing or the preparation thereof of an inoperable vehicle by another vehicle for which charge is levied, either directly or indirectly.
