1. PURPOSE

The purpose of this RFQ is to appoint a suitable independent service provider to host a workshop for SANParks' Managing Executives and General Managers, to assist in detailing the views of the executives and managers of how the financial sustainability report should entail. A facilitator who is proficient in scenario planning is required to conduct this workshop.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

SANParks is in the process of developing a 20-year Outlook Financial Feasibility & Sustainability Model. The project is premised on the development of a robust organisation-wide financial model incorporating feasibility and sustainability elements which will be imperative for the financial self-sustenance of the organisation and the parks which it operates. In order to provide valuable input to the project, SANParks decided on a workshop which includes its EXCO and OPSCO members.

SANParks requires the services of a professional facilitator that is proficient in scenario planning, to coordinate the meeting and provide a report on the recommendations based on the deliberations of the day

3. SCOPE OF WORK

The Facilitator will be responsible for the overall delivery of the workshop made up of 28 OPSCO and 8 EXCO members virtually via Microsoft Teams. The work will include but may not be limited to the following tasks:

- Familiarise with SANParks environment
- Prepare workshop agenda and any required materials required in consultation with SANParks
- Lead workshop, acting as lead facilitator
- Facilitate all of the sessions and transitions between sessions where necessary
- Remain engaged and interact regularly with the teams throughout the workshops
- Ensure that platform for multi-stakeholder discussion is created
- Ensure that participants are involved in preparation of the roadmap
- Develop roadmap identifying the gaps in existing sustainability together with project team
- Develop workshop summary report

5.1 COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents)

The verification during this stage is to review bid responses for purposes of assessing compliance with RFB requirements, whereby a bidder may be disqualified if they do not fully comply, which requirements include the following:

- Submission of fully completed SBD1 (Invitation to Bid),
- Submission of an official quotation on the company letter head
- Submission of fully completed SBD 4 (Declaration of Interest),
- Submission of fully completed SBD 6.1 (Preference Claim Certificate), accompanied by the original or certified B-BBEE Status Level Verification Certificate or original B-BBEE Sworn Affidavit,
- Submission of fully completed SBD8 (Declaration of Bidders Past SCM Practice),
- Submission of fully completed SBD9 (Certificate of Independent Bid Determination),
- Proof of registration with National Treasury Central Supplier Database (CSD).

5.2 FUNCTIONALITY REQUIREMENTS

Bidders are not eligible to proceed to the next phase of evaluation of Price where they score less than the minimum threshold [75%] prescribed for functionality. SANParks promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team. The minimum functional threshold will be 75%.

5.3 EVALUATION CRITERIA AND WEIGHTING

The **RFQ** stipulated that the responses to be evaluated using the 80/20 preference points system in accordance with the PPPFA guidelines. Based on this system the points will be allocated as follows:

5.3.1 Evaluation Formula for Price

The following formula will be applied to calculate the scores:

The following PPPFA formula was used to evaluate the price proposals submitted by bidders, this formula was used because price was the only criterion that was scored i.e. the whole 80 points were allocated to price.

10. FINAL AWARD

SANParks nominates the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation.

SANParks reserves the right not to award to the highest points scorer in accordance with S2(1) (f) of the Act (PPPFA).
