Only service providers registered in the Ulundi Municipality suppliers' database and registered with Central Supplier Database (CSD) will be considered.

Bid documents may be obtained on the **Ulundi Municipal Website at www.ulundi.gov.za**. Bid documents must be submitted in a sealed envelope clearly marked with the bid number, closing date and, dropped off in the tender box at SCMU, Ulundi Municipality, Corner of Princess Magogo and King Zwelithini Street, Ulundi, 3838 by no later **12H00 of the above stated closing dates**. The bid box is generally open from 07h30 to 16h30 Monday to Thursday and 07h30 to 15h15 Friday. All quotes must be submitted on the official forms – (Not to be retyped). This bid is subject to the general conditions of contract (GCC) and any other special conditions of contract.

THE FOLLOWING ARE MANDATORY: CSD summary report, valid tax clearance or SARS login pin, a certified copy of the most recent municipal account in which the business is registered, copies of ID of members of the entity, CIPRO, and relevant Business certificates. Bidders are requested to sign where necessary and initial each page on the Bid Documents. **The tender is valid for 90 days.**

The Bids will be evaluated using 80/20 Preferential Procurement Point system where 80 points are for the price, and 20 are for specific goals according to the PPPFA 2000 Act no. 5 of 2000 and SCM Regulation 2022. Where there's functionality two stage evaluation process will be followed, first evaluate functionality and only tenders that score the minimum threshold for functionality will be advancing to the second stage of evaluation on point for price and specific goal.

Late tenders will not be accepted, and the Ulundi Municipality reserved the right not to make an award. Failure to comply with the above conditions will invalidate your offer.

Kindly note that the successful bidder will be subjected to a screening process prior to the bid being awarded, should it be discovered that a successful bidder provided misleading information he/she will be disqualified with immediate effect.

SPECIFICATION AND SCOPE OF WORK

The successful bidders shall be required to assist the Ulundi local municipality's legal unit in rendering legal services on an ad hoc basis in the following categories:

The attorneys/ law firms must be registered with the relevant law societies, have an understanding of municipal law and must inter alia be able to execute the following functions, which includes but not limited to the following:

- A) Property registration and conveyance
- B) Legal opinion
- C) Labour litigation
- D) Drafting of agreements
- E) Land restitution
- F) Labour disputes
- G) Legislative drafting and review
- H) Town planning litigation
- I) Policy formulation
- J) Civil and criminal litigation

It is important that the firm of attorneys ensure continuous quality and consistency of services.

1. Duration of the contract

The duration of the panel of attorneys is **3 years**. The firm of attorneys will be required to enter into a formal service level agreement governing the activities of the panel of attorneys with Ulundi local municipality within 30 days of the receipt of a letter of appointment.

The firm of attorneys will be required to provide effective and competent legal services as and when instructed subject to Ulundi local municipality supply chain management policy.

Appointment to the panel does not in any way guarantee that a firm of attorneys will receive instructions.

2. Documents and content required

The bidders must include the following in their submission:

2.1 The firm's profile, which must include the Directors, Partners and / or Associates of the firm.

2.2 Knowledge and experience in the selected category as outlined in the above, which must include a minimum of five (5) previous and / or current projects being done or completed.

2.3 Bidders must provide the following:

- Summary of work performed or under way;
- Year in which the project commenced and was completed; and
- At least three (3) contactable references for the projects referred to herein.

- 2.4 Curriculum vitae of the firm's team members in the respective categories, which must, amongst others, include:
- 2.4.1 Experience of the team members in the selected category as mentioned in above; and
 - 2.4.2 Tertiary and all relevant qualifications with full particulars, including the date obtained and the name of the institution from which the qualification was obtained.
- 2.5 A list of Junior and Senior Counsel who are associated with the firm and their track records in line with the requirements of the Municipality. Preference will be given to Counsel who have experience and / or knowledge in the selected categories.
- 2.6 Proof of Company / Firm's Registration with a South African Law Society.
- 2.7 Certified ID copies of all Members/Directors of Company, Firm or Sole Proprietor.
- 2.8 Proof of VAT registration, where applicable.
- 2.9 Bank details (together with an original cancelled cheque/bank stamp or original letter from Financial Institution)
- 2.10 Original or certified copy of valid B-BBEE status level verification
- 2.11 Certified copy of the Attorney Fidelity Fund Certificate – failure to submit the Fidelity Fund Certificate will lead to non-registration on the Panel.
- 2.12 Professional Admission Registration Certificates must be submitted with the bid.

3. General requirements

- 3.1 Only legal practices established in accordance with the provisions of the Attorneys Act, 1979 (Act No 53 of 1979 as amended) will be considered.
- 3.2 A contract will be concluded with each successful firm to the panel and be obliged to sign confidentiality and indemnity agreements.
- 3.3 Panel members are not guaranteed any work under this tender proposal. The engagement will be on an assignment basis.
- 3.4 Ulundi Local Municipality may, at its sole discretion, award an assignment or any part thereof to more than one panel member or may at its own discretion vary an instruction to include more work.
- 3.5 The firm of Attorneys may not cede or assign any part of its agreement with the Ulundi Local Municipality nor sub-contract any part of the work assigned to them without prior written authorization of the Ulundi Local Municipality, i.e. if the work assigned is at the Magistrates Court.
- 3.6 The firms of Attorneys must declare any interest it has in an assignment as well as declare any possible conflict of interest with the Ulundi Local Municipality in the pursuance of the proposed assignment. If any conflict of interest is discovered during the assignment, the Council reserves the right to summarily cancel the Agreement and demand that all information, documents and property of the Council be returned forthwith.
- 3.7 The database registration is valid for a period of three (3) years.
- 3.8 The respective firms of Attorneys will report to the Deputy director: Legal Services.
- 3.9 Intellectual Property Rights – All copyrights and intellectual property rights that may result as consequences of the work to be performed will become the property of the Council.

- 3.10 Firms of Attorneys must hand over all documents and information in any format, including copies thereto, that it received from Ulundi Local Municipality or that it had access to during the assignment immediately after completion of the assignment.
- 3.11 The Council reserves the right to interview panel members that are shortlisted for specific assignments.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim regarding preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
- (b) **“price”** means an amount of money tendered for goods or services and includes all applicable taxes less all unconditional discounts.

- (c) **“Rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes.
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“The Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
