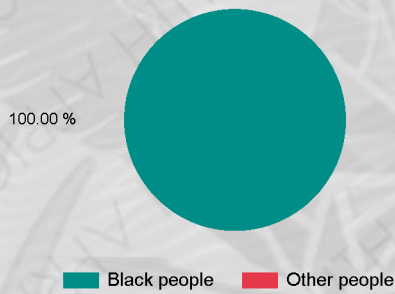

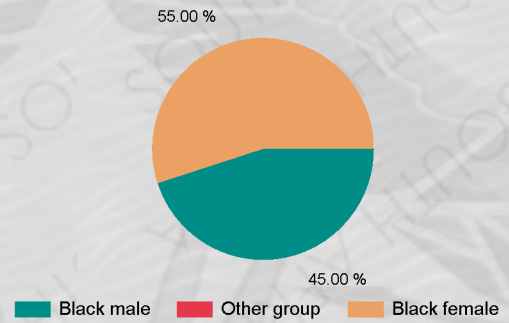

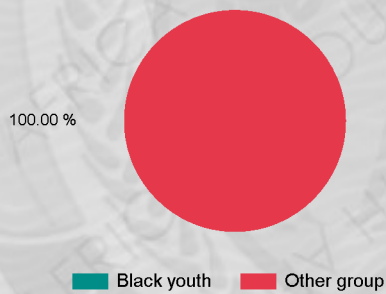
People % Ownership



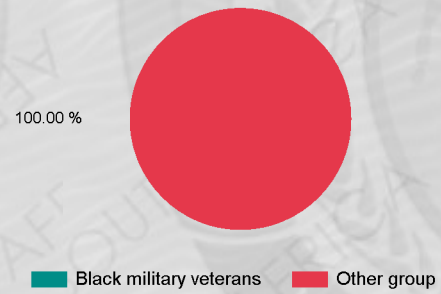
Gender % Ownership



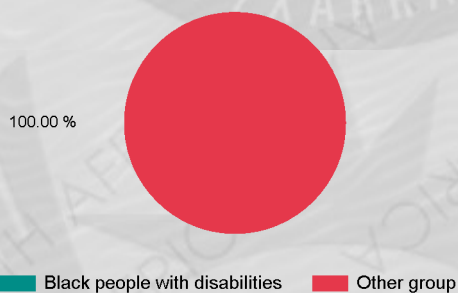
Youth % Ownership



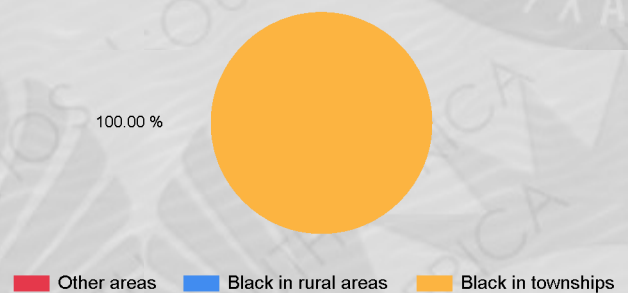
Military veteran % Ownership
