Winnie Madikizela Mandela Local municipality seeks to appoint a qualified and experienced service provider for supply, installation and configuration of IT equipment at WMMLM Civic Centre and Mphuthumi Mafumbatha stadium.

- (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
- (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
