#### **1. INTRODUCTION AND PURPOSE**

The supply and delivery of a specialised vector control service to the City of Tshwane as and when required for a period of 01 year.

The quotation requires the services of a registered pest control operator for the application of the identified vector control measures, which causes directly or indirectly zoonotic disease. The quotation also requires the operator to administer the necessary control measures as and when required.

The control sections are as follows:

- Section A - The chemical control of flies
- Section B – The chemical control of mosquitoes
- Section C - The control of rodents through rodenticides

#### **2. BACKGROUND**

According to section 24 of the Constitution of the Republic of South Africa as amended, everyone has the right to an environment that is not harmful to their health and well-being. Chapter seven of the Constitution also states clearly as one of the objects of the Local Government: “to promote a safe and healthy environment”.

Municipal Health Service has a legal obligation according to the National Health Act, 61 of 2003, also Health Act, 63 of 1977 to ensure that a safe and healthy environment do not include infestations and population explosions of any known vectors which can lead to creating an unhealthy environment for the residents of the city.

This quotation will benefit the Health Department in the City of Tshwane in ensuring a safe and healthy environment through the elimination of flies, mosquitoes and rodents. The listed vectors below may in addition, pose a health nuisance, cause irritation to both humans and animals, resulting in loss of productivity, cause unnecessary aggression and constitute vector related disease outbreaks. When required, the Health department will utilize the quotation for mosquito infestation in wetlands and other sensitive areas where bio-application is compulsory to protect bio-life.

The main vectors affecting the city and known to carry zoonotic diseases are as follows:

## **5.2 MANDATORY REQUIREMENTS**

- 5.2.1 Pest Control officer/s must be registered with the Department of Agriculture and must be in possession of a registration certificate, such proof must be provided.
- 5.2.2 Only South African registered insecticides and rodenticides may be tendered, and the South African manufacturers name must be evident on the Labels. Submit, (namely the first page of the labels), clearly marked with the quotation item number and filed in the same order as the quotation, together with the quotation bid.
- 5.2.3 Ownership documentation or a lease agreement must be submitted as proof for licensed, namely two (2) bakkies with canopies or similar (Certified copies of registration or lease agreement required).

**\*Note, bidders failing to hand in the mandatory documents for the sections they are bidding for will not be considered for that section. A bidder will be required to have all labour, vehicles and equipment offered available for the duration of this quotation. If a bidder does not comply with the minimum requirement, they will not qualify to quote.**

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## 3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

### 3.1. POINTS AWARDED FOR PRICE

#### 3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

#### 4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
