1. PURPOSE

The purpose of this request is to appoint a service provider for the servicing and maintenance of LV and MV and Electrical Compliance within the Tsitsikamma Section of Garden Route National Park for a period of 60 months.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. SCOPE OF WORK

SPECIFICATION

ELECTRICAL MAINTENANCE CONTRACT FOR MEDIUM VOLTAGE (MV), LOW VOLTAGE (LV), BACKUP GENERATORS, TRANSFORMERS AND ELECTRICAL COMPLIANCE SERVICES

1. CONTRACT TITLE

Provision of Electrical Maintenance Services for Medium Voltage (MV) Networks, Low Voltage (LV) Installations, Backup Generators, Transformers, Electrical Repairs and Issuing of Certificates of Compliance (CoCs) at Tsitsikamma National Park.

2. OBJECTIVE

The objective of this contract is to appoint a suitably qualified and accredited electrical contractor to provide preventative maintenance, breakdown maintenance, repair services, testing, inspection, statutory compliance and emergency call-out services for electrical infrastructure within Tsitsikamma National Park.

The contractor shall ensure the continued safe, reliable and efficient operation of all MV and LV electrical systems, backup generators, transformers, switchgear, substations and associated electrical equipment.

3. CONTRACT PERIOD

The contract shall be valid for a period of sixty (60) months from the date of appointment.

4. SCOPE OF WORK

The scope shall include but not be limited to the following:

4.1 MEDIUM VOLTAGE (MV) ELECTRICAL SYSTEMS

Inspection, maintenance and repair of:

- MV distribution networks up to 11kV.
- Ring Main Units (RMUs).
- MV switchgear.
- MV overhead lines.
- MV underground cables.
- Terminations and joints.
- Protection equipment.
- Earthing systems.
- MV substations.
- Surge protection devices.

Services shall include:

- Quarterly inspections.
- Thermal imaging of switchgear and terminations.
- Insulation resistance testing.
- Earthing resistance testing.
- Cable fault identification.
- Repair of MV cable faults.
- MV switching operations where required.
- Replacement of damaged components.
- Cleaning and servicing of equipment.
- Updating and maintenance of single-line diagrams.

4.2 LOW VOLTAGE (LV) ELECTRICAL INSTALLATIONS

Maintenance and repairs of:

- Main distribution boards.
- Sub-distribution boards.
- Distribution kiosks.
- Circuit breakers.
- Contactors.
- Electrical control panels.
- Building wiring installations.
- Power outlets.
- Lighting systems.
- Street lighting systems.
- Flood lights.
- Emergency lighting systems.

- Electrical reticulation systems.

Services shall include:

- Preventative maintenance.
- Fault finding.
- Replacement of defective components.
- Load balancing.
- Tightening of electrical connections.
- Thermal imaging.
- Electrical safety inspections.
- Voltage and load testing.

4.3 EMERGENCY BREAKDOWN SERVICES

The contractor shall provide:

- Twenty-four (24) hour emergency response services.
- Seven (7) days per week availability.
- Breakdown attendance within:
 - 4 hours for critical failures.
 - 24 hours for non-critical failures.

Critical failures include:

- MV power interruptions.
- Generator failures.
- Transformer failures.
- Main distribution board failures.
- Safety-related electrical faults.

5. BACKUP GENERATOR MAINTENANCE

The contractor shall service and maintain all standby generators within the park.

Services shall include:

Monthly Inspections

- Visual inspections.
- Battery condition checks.
- Fuel system inspections.
- Coolant level checks.
- Lubrication checks.
- Control panel inspections.
- Automatic transfer switch inspections.

Quarterly Servicing

- Engine oil replacement.
- Oil filter replacement.
- Fuel filter replacement.
- Air filter inspections.
- Functional testing.
- Safety shutdown testing.

Annual Major Service

- Comprehensive engine inspection.
- Alternator inspection.
- Load bank testing.
- Fuel system servicing.
- Cooling system servicing.
- Battery load testing.
- Control system testing.

The contractor shall submit a service report after each maintenance visit.

6. TRANSFORMER MAINTENANCE

The contractor shall inspect and service all MV/LV transformers.

Services shall include:

- Visual inspections.
- Oil level inspections.
- Oil leak inspections.
- Bushings inspections.
- Earthing inspections.
- Thermographic inspections.
- Cleaning of transformers.
- Tightening of terminals.

Annual Transformer Testing

- Oil dielectric strength testing.
- Oil condition analysis.
- Insulation resistance testing.
- Winding resistance testing.
- Earth resistance testing.

The contractor shall provide recommendations for repairs or replacement where necessary.

The contractor shall maintain transformer service records and condition reports.

7. CERTIFICATES OF COMPLIANCE (CoC)

The contractor shall be registered with the Department of Employment and Labour and be authorised to issue Certificates of Compliance.

Services shall include:

- Inspection and testing in accordance with SANS 10142.
- Issuing of CoCs for new installations.
- Issuing of CoCs after alterations.
- Issuing of CoCs after repairs.
- Verification of existing installations.
- Preparation of defect reports.

All CoCs shall be submitted to SANParks within five (5) working days of completion of testing. Existing SANParks MV documentation also requires electrical testing and the issuing of Certificates of Compliance in accordance with electrical regulations.

8. REPORTING REQUIREMENTS

The contractor shall provide:

Monthly Reports

- Work completed.
- Breakdown incidents.
- Materials utilised.
- Outstanding defects.
- Safety incidents.
- Recommendations.

Annual Condition Assessment Report

The report shall include:

- Condition of transformers.
- Condition of generators.
- Condition of substations.
- Condition of MV and LV infrastructure.
- Asset replacement recommendations.
- Risk assessment of electrical infrastructure.

9. HEALTH, SAFETY AND ENVIRONMENTAL REQUIREMENTS

The contractor shall comply with:

- Occupational Health and Safety Act 85 of 1993.
- Construction Regulations.

- Electrical Installation Regulations.
- Environmental Management requirements of SANParks.
- Lock-Out and Tag-Out procedures.
- Permit-to-Work requirements.
- Hazard Identification and Risk Assessment procedures.

10. APPLICABLE STANDARDS

All work shall comply with the latest editions of:

- SANS 10142-1.
- SANS 10199.
- SANS 10313.
- Occupational Health and Safety Act No. 85 of 1993.
- Applicable IEC Standards.
- NRS Standards.
- Eskom Distribution Standards.
- Municipal and Supply Authority requirements.

These standards are consistent with those identified in the existing Tsitsikamma MV infrastructure specifications.

11. MINIMUM CONTRACTOR REQUIREMENTS

The bidder must:

- Be registered with the Electrical Contracting Board of South Africa (ECB).
- Be registered with the Department of Employment and Labour.
- Have Wireman's Licence personnel available.
- Have at least one Registered Installation Electrician or Master Installation Electrician.
- Have MV operating experience on systems up to 11kV.
- Submit proof of Public Liability Insurance.
- Submit proof of COIDA registration.
- Submit valid Letter of Good Standing.
- Provide at least three references for similar work completed within the last five years.

12. PRICING SCHEDULE

The contractor shall provide:

- Maintenance schedules.
- Service reports.
- Inspection reports.
- Test certificates.
- Transformer test results.
- Generator service records.
- Electrical drawings updates.
- Certificates of Compliance (CoCs).
- Annual condition assessment reports.

4. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents) - RETURNABLES
