TERMS OF REFERENCE FOR SERVICES FOR A GRAP SPECIALIST TO REVIEW 2021/ 2022 FINANCIAL STATEMENTS

1. INTRODUCTION

The SADPMR is listed as a schedule 3A public entity in terms of the Public Finance Management Act (PFMA). In terms of paragraph 55 of the PFMA, Accounting Authority of the public entity must prepare financial statements for each year in accordance with generally recognised accounting practices as approved by the Accounting Standard Board.

2. OBJECTIVE

The SADPMR requires the services of a GRAP specialist to review financial statements for compliance with Generally Recognised Accounting Practice as approved by the Accounting Standard Board and provide support for 2021/22 financial year audit.

4. SCOPE OF WORK

The specialist will review the 2021/ 2022 financial statements for compliance with the Generally Recognised Accounting Practice as approved by the Accounting Standard Boards and provide support and advise.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *per se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

Bid rigging is, therefore, an agreement between competitors not to compete.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.
