BACKGROUND

TCTA is planning an in-person Culture Day on the 14 March 2025 at the Raddison Blue Gautrain, Sandton for its full staff complement. The purpose of the event is to recognise TCTA Staff members for excellence. The service of an experienced interpreter is required to assist a deaf employee with English sign language interpretation to ensure participation in the programme.

SCOPE OF WORK

Service providers are required to provide the following services:

- Three (3) hours of South African sign-language interpretation for an English-speaking employee at a corporate event.

b) The services must be provided on the 14th of March 2025 from 12h00 to 15h00 at Raddison Blue Gautrain, Sandton.

COMPANY EXPERIENCE REQUIRED

The Bidder must have worked on a minimum of two (2) interpretation projects during period of operation. Fully completed **Annexure A** (see attachment below) with a minimum of two projects must be submitted. Proof of projects in the form of project completion letters / progress reports / reference letters of similar work completed must be submitted.

RECOMMENDED PERSONNEL EXPERIENCE

The sign language interpreter must have 2 years' experience as a sign language interpreter. Fully completed **Annexure B** (see attachment below) must be completed and submitted. No Curriculum Vitae (CV) will be accepted.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

(a) "tender" means a written offer in the form determined by an organ of state in response to an

invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;

- (b) “price” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “rand value” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “tender for income-generating contracts” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “the Act” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
