1. PURPOSE

The South African Diamonds and Precious Metals Regulator ('the SADPMR) wishes to appoint an actuarial consultant to provide the post-retirement medical aid liability valuation report.

2. BACKGROUND

The South African Diamond and Precious Metals Regulator (SADPMR) is listed as a schedule 3A Public entity of the Public Finance Management Act. On inception, the SADPMR absorbed 24 employees from South African Diamond Board with the provision of paying employer contribution on post-retirement medical aid. At this stage the SADPMR on monthly basis pays 66.5% and the retiree pays 33.5% on the medical aid premium.

3. SCOPE OF WORK

For the employer to be able to determine a guideline of managing the current post-retirement medical aid benefit in the SADPMR, there is a need to source a service of qualified actuaries focusing on post-employment benefit obligations.

DELIVERABLES

- The successful bidder will be required to execute the work in a satisfactory manner.
- The selected service provider will be required to provide extensive report on post-retirement medical aid liability.
- In that, the appointed actuaries would be required to provide a comprehensive report with values for settlements to former employees as well values for a possible transfer to another financial institution.
- Provide recommendations regarding the management of post-retirement medical aid based on the latest research and trends.

Broad-Based Black Economic Empowerment (B-BBEE)

- Provisions of the Preferential Procurement Policy Framework Act (PPPFA) 2017 and its regulation will apply in terms of awarding points.

- Bidders are required to submit original and valid B-BBEE status level Verification to substantiate their B-BBEE rating claims.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
