TENDER NOTICE AND INVITATION TO TENDER (Incorporating SBD1)

The South African National Roads Agency SOC Limited (SANRAL) invites tenders for the periodic maintenance of the National Route 2 Section 8 from Harkerville (km 47.2)

to Natures Valley (km 79.8). This project is in the province of Western Cape in the district municipality of Garden Route and local municipality of Bitou. The approximate duration is 6 months including 2 Months for the

Mobilisation Period.

CIDB Regulation 25(1B) will not be applicable to this contract.

Only tenderers with a B-BBEE contributor status level of 1, 2, 3 or 4 and who is a QSE and who are registered on the National Treasury Central Supplier Database and meet the minimum threshold designated for local production and content as stated in the Tender Data C.2.1.1, are eligible to tender.

It is estimated that tenderers should have a CIDB contractor grading designation of 6CE or higher, however tenderers attention is drawn to clause C.2.1.1 of the Tender Data when submitting their tender.

Tenders from tenderers registered as potentially emerging enterprises but with a CIDB contractor grading designation lower than a contractor grading designation determined in accordance with the sum tendered, or a value determined in accordance with Regulation 25(7A) of the Construction Industry Development Regulations, will not be accepted.

It is a requirement of this project that the successful tenderer subcontract a minimum of thirty percent (30%) of the work by the end of the contract to Targeted Enterprise(s) as defined in the Contract Data.
