TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER TO RELOCATE ASSETS TO THE NEW BUILDING OF THE SADPMR AT 48 BONAERO DRIVE KEMPTON PARK

1. PURPOSE OF THE ASSIGNMENT

The purpose of the assignment is for South African Diamond and Precious Metals Regulator to appoint a Service Provider for assets* removals from the old office at 251 Fox street and Berea Road and deliver to the new offices at 48 Bonaero Drive in Kempton Park.

* **“assets”**: moveable assets that may or may not require disassembly before move and reassembly at new premises, and include but not limited to: furniture, workstations, computer equipment, printers and peripherals, other equipment and machinery, appliances, kitchen contents, books, files and framed picture/art.

2. BACKGROUND

- SADPMR: Head Office will be relocating to the new building situated at 48 Bonaero Drive in Kempton Park.
- The SADPMR invites specialist service providers to come for site inspection to assess the existing assets and submit bid proposals.

3. SCOPE OF WORK AND DELIVERABLES

Service providers are invited to submit quotations for the execution of the following services:

- **Relocation of assets**
 - a) The service involves disassembly and reassembly of assets* for about 120 staff members.
 - b) Provide boxes and bubble wrap for 120 computer equipment
 - c) Provide 70 boxes for scales.
 - d) In transit insurance
 - e) All assets relocated need to be carefully marked to ensure that the correct workstation is reassembled and tracked on the asset register.
 - f) Specialist service providers to come for site inspection to assess the existing assets and submit bid proposals.
 - g) The successful bidder must be able to commence with the execution of the required services within one (1) week from the date of awarding of the contract.

4. DELIVERABLES

- The successful bidder will be required to execute the work in a satisfactory manner.
- Selected service provider will be invited to make a presentation of their Project Execution Plan.

5. EVALUATION METHODOLOGY

Cost

- The service provider will be requested to provide a quote regarding the work to be undertaken for this project. The total cost must be VAT inclusive and should be quoted in South African currency (i.e. Rands). Detailed breakdown of the total bid must be attached.

Broad-Based Black Economic Empowerment (B-BBEE)

- Provisions of the Preferential Procurement Policy Framework Act (PPPFA) 2017 and its regulation will apply in terms of awarding points.
- Bidders are required to submit original and valid B-BBEE status level Verification to substantiate their B-BBEE rating claims.
- Bidders who do not submit their B-BBEE status level verification certificates or are non-compliant contributors to B-BBEE will not qualify for preference points for B-BBEE.
- In a case of Exempted Micro Enterprise (EMEs), AO/AA must ensure that the B-BBEE Status Level Verification Certificates submitted are issued by the following agencies:
 1. Verification agencies accredited by SANAS; or
 2. Registered auditors approved by IRBA

Commitment to deliver the required security system

The successful bidder must be able to commence with the execution of the required services within (1) week from the date of awarding of the contract.

Bids will be evaluated on 80/20-point system as outlined in the PPPFA of 2017.
