- Research Radiation Biophysics
- The supply of accelerator-produced radioactive isotopes for nuclear medicine and research

Evaluation Process

- Evaluation of proposals:

All proposals will be evaluated by Supply Chain Management for administrative compliance, functionality, price and B-BBEE. Based on the results of the evaluation process and upon successful negotiations, iThemba LABS will approve the awarding of the contract to the successful bidder.

- Preference points system:

The 80/20 preference point system will be used where 80 points will be dedicated to price and 20 points to B-BBEE status. "If all bids received are more than R 1 000 000.00, this request is automatically cancelled".

Subject to section 2(1)(f) of the PPPFA, the contract will be awarded to the tenderer scoring the highest points.

SPECIFICATIONS:

Design, Manufacture, Supply and Delivery of a Radioisotope Dispensing System

Radioisotope Dispensing System Design and Specifications

This Radioisotope Dispensing System must automate the dispensing of radioactive solutions into capsules with high precision and speed, all while maintaining operator safety. With its pneumatic, mechanical, and thermal components, the system must operate efficiently without radiation exposure, making it suitable for use in high-radiation environments. The design must integrate advanced controls and safety features to ensure safe, accurate, and reliable operation.

This system must be designed to automate the precise dispensing of radioactive solutions into a source capsule while ensuring operator safety in a high-radiation environment. It must also be tested, and cold run.

Below are the key specifications and components for this system:

1. System Components and Operation:

A. Dispensing Mechanism:

1. Conical Vial Handling:

- A 1 ml conical vial containing radioactive solution is placed at Point A.
- Grippers must securely hold and position the vial for dispensing.

2. Automated Arm and Dosing:

- A pneumatic arm with a vacuum solenoid will draw 2 μ L of radioactive solution from the vial.
- The solenoid must operate precisely, ensuring accurate and consistent dosing.
- The arm must position the vial and source capsule with 99.98% accuracy within a 2 mm radius.

B. Source Capsule Handling:

1. Pneumatic Carriages:

- The source capsule, containing the radioactive material, must be moved by pneumatic carriages.
- These carriages must position the capsule at the correct location for dispensing and heating, ensuring minimal operator exposure to radiation.

2. Interchangeable Capsule Adapters:

- The system must support interchangeable source capsules with custom adapters, making it adaptable to different capsule types.

C. Heating Mechanism:

1. Focused IR Heat Source:

- A focused infrared (IR) spotlight must direct heat specifically to the 2 mm eye of the capsule.
- The temperature range must be between 50–100°C, ensuring efficient drying of the radioactive solution.

2. Precision Heating:

- The IR spotlight must focus heat on a 2 mm radius, preventing overheating of surrounding areas.

D. Control and Remote Operation:

1. Human-Machine Interface (HMI):

- Operators must be able to control and monitor the system remotely using an HMI that displays real-time system diagnostics.
- The HMI must allow adjustments to dispensing volume, heating intensity, and cycle time.

2. Programmable Logic Controller (PLC):

- A Festo PLC (or similar) must control the mechanical operations, including the pneumatic actuators and the precise movements of the vial and capsule.
- The system must include Festo actuators (or similar) for accurate and rapid movement of the vial and capsule.

3. Cycle Time:

- Each dispensing and heating cycle must be completed in less than 8 seconds, ensuring high throughput and efficiency.

2. System Specifications:

A. Performance Requirements:

- Accuracy: The system must dispense with 99.98% accuracy within a 2 mm radius.
- Cycle Time: Each cycle, from dispensing to drying, must take no longer than 8 seconds.
- Heat Application: The IR spotlight must provide focused heat on a 2 mm radius, with temperatures ranging from 50–100°C.

B. Durability and Safety:

- Radiation-Resistant Components: The system must be mechanically robust and resistant to high radiation levels, with no electronics exposed to radiation.
- Operator Safety: The system's design must limit operator exposure using pneumatic carriages that automatically move components in and out of the shielded areas.

3. Supplier Requirements:

The supplier must have proven experience in designing mechanical systems for high-radiation environments. All components should be carefully engineered to ensure reliable, precise performance in such conditions.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
