The South African National Roads Agency SOC Limited (SANRAL) invites tenders for the provision of Consulting Engineering Services for the Reseal on National Route R40 Section 5 from Arthur's Seat (Km 53.0) to Hoedspruit (Km 93.97). This project is in the provinces of Limpopo and Mpumalanga, in the local municipalities of Maruleng and Bushbuckridge, the approximate programme is for design and construction documentation to be completed by **January 2025**, followed by supervision of **12 months** (including 2-month mobilisation period), commencing **September 2025**.

Only tenderers who are registered on the National Treasury Central Supplier Database and meet the minimum requirements for the key persons as stipulated in Clause C.2.1 at the tender closing date, are eligible to tender.

Joint Ventures (JV) will be allowed on condition that one JV partner is a Targeted Enterprise. The JV partner will, however, not contribute to sub-contract target for Targeted Enterprises.
