1. BACKGROUND INFORMATION

Bidders with 2GB grading are invited to bid for the refurbishment of Sefako Makgato fire station in Lepelle-Nkumpi local municipality.

2. SCOPE OF WORK

- 2.1 Construct and installation of five water borne (flushing) outside toilets and two showers linked to the existing sewer pipeline (the interior wall of showers must be tiled completely from floor up to ceiling level).
- 2.2 Replace the sliding door with pivot glass door (1.3 width) in an aluminium frame.
- 2.3 Replace wooden boardroom door (double door at 1.5-meter width).
- 2.4 Repositioning of the following amenities or items, concrete washing basin, two air conditioners, geyser and demolishing of car shade made of steel poles and IBR roofing.

7. CONDITIONS FOR THE BID

- 7.1 The employer and each Bidder submitting a Bid offer shall comply with these terms and conditions of Bid. In their dealings with each other, they shall discharge their duties and obligations timeously and with integrity, and behave equitably, honestly and transparently.
- 7.2 The bidder must attach following with the tender:
 - 7.2.1 The legal registration certificates of the business entity.
 - 7.2.2 Tax access code (pin) issued by the South African Revenue Services to verify your tax matters.
 - 7.2.3 B-BBEE certificate or SWORN affidavit from Commissioner of Oath.
 - 7.2.4 Proof of registration with professional authorities. **(Where Applicable)** proof of registration with the central supplier database (CSD)
 - 7.2.5 Proof that municipal rates and taxes are not in arrears, or a lease agreement or a letter from traditional council
- 7.3 **The bidder must complete the attached forms** (failure to do so will result to disqualification)

- 7.4 Bidders must take note that briefing session will not take place. Bidders may send electronic mails enquiries related to this bid.
- 7.5 The bid price must remain valid for a period of 90 days calculated from the closing days.
- 7.6 The offer shall be open for acceptance by the Municipality during the validity period of 90 days.
- 7.7 The bidder or any of its directors has not:
 - 7.7.1 Listed on the register of bid defaulters in terms of the Prevention and Combating of Corrupt Activities Act of 2004 as a person prohibited from doing business with the state.
 - 7.7.2 Abused the employers supply chain management system.
 - 7.7.3 Failed to perform on any previous contract and has been given a written notice in this effect.

- 7.7.4 All information and details must be legible/ readable.
- 7.8 If the bidder fails to fulfil the contract when called upon to do so, the municipality may, without prejudice to its other rights, withdraw or cancel the contract that may have been entered into between the bidder and the Municipality.
- 7.9 Each communication between the Municipality and a Bidder shall be to or from the Municipality only, and in a form that can be read, copied and recorded. Writing shall be in the English language. The Municipality shall not take any responsibility for non-receipt of communications from or by a Bidder. The name and contact details of the Municipality are stated.
- 7.10 Accept that the employer will not compensate the Bidder for any costs incurred in the preparation and submission of a Bid offer, including the costs to demonstrate that aspects of the offer satisfy requirements.
- 7.11 The Municipality may accept or reject any variation, deviation, bid offer or alternative Bid offer, and may cancel the Bid process and reject all Bid offers at any time before the formation of a contract. The employer shall not accept or incur any liability to a Bidder for such cancellation and rejection but will give written reasons for such action upon written request to do so.
- 7.12 No bids will be considered from persons in the service of the state (as defined in regulation 1 of the local government: municipal supply chain management regulations)
- 7.13 Bid documents may not be retyped, redrafted or copied. Only original copy from the municipality will be accepted.
- 7.14 Use of correctional fluid is prohibited
- 7.15 Any alteration made by the bidder must be initialled.
- 7.16 The bidder must ensure that all pages of the tender documents are initialled.
- 7.17 Successful bidder will be required to enter into formal contract with the municipality.
