**Introduction to the NRF**

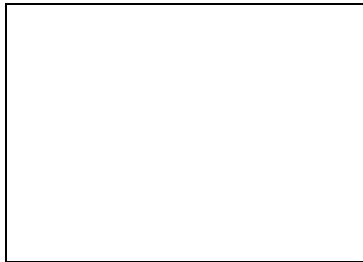
