CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

CALLS FOR QUOTATIONS FROM SUITABLY QUALIFIED SERVICE PROVIDERS TO PROVIDE BOARD MANAGEMENT SOFTWARE

1. BACKGROUND

- The National Heritage Council (NHC) is an Entity of the Department of Sports, Arts and Culture, established in terms of Section 3 of the National Heritage Council Act No. 11 of 1999, as amended (Act). It is responsible for the preservation of the country's heritage and its areas of focus are policy development, public awareness, knowledge production and funding of heritage projects.
- The Minister of Arts and Culture has, in terms of Section 5(1) (a) of the Act, appointed members of the public of the Republic of South Africa into the Council of the NHC ("the Council") to manage the affairs of the NHC, in terms of the Act and regulations made in terms of the Act, from time to time, and in accordance with good corporate governance principles. Nine (9) members are appointed by the MEC's of all the Provinces responsible for arts and culture in terms of Section 5(1) (b) and the rest are members by their being Chairpersons of certain declared cultural institutions in terms of Section 5(1) (c) of the Act.

2. SCOPE OF WORK

The NHC hereby requests quotations for an electronic Board Management Software. The NHC requires access for 25 users. The Board Management Software should be able to fully facilitate the electronic distribution of Board meeting packs to official NHC handheld devices. The solution should also be able to ease the logistics of compiling the packs and improve overall governance within the NHC. The NHC expects the system to possess the following functionalities:

- The system should be securely accessible by all board members from any location and should support strong security features such as encryption or two-phase authentications;
 - The system must be capable of providing enhanced security tools like remote locking and cater for users on mobile platforms and should also support most modern web browsers;
 - The system should allow for seamless scheduling of meetings with an online, collaborative meeting space where you can include agendas; attendee list; meeting minutes; pre-and post-meeting actions and add related documents;
 - The system should provide for a meeting pack function which allows one to easily collate meeting documents, including agendas, minutes into one file. Board members should be able to make notes and document sign off on their meeting packs, with or without Wi-Fi;
 - The solution should provide a centralised, collaborative platform where everyone can access and contribute to good decision making by capturing all decisions made and allowing easy to create surveys;
 - The system should allow Board members to use its functions and content both online and offline and provide Board members with full access to minutes and resolutions;
 - Voice and video recording;
 - The system should have the ability to create virtual rooms for board committees or smaller groups to allow secure collaboration before and after meetings; and
 - The system should have minute taking capabilities to enhance minute taking processes.
- The period of the contract will be for 24 months.

3. DELIVERABLES

- Provide an electronic Board Pack Software as per above requirements;
- Role and user profile management;
- Network offline operational capability;
- Storage model;
- Hardware requirements;
- Notification and reporting capabilities;
- Dashboard capabilities;
- Data classification requirements (sensitive, secret, confidentiality);
- Password formatting and expiry management;
- Data encryption; and
- Collaborative capabilities.
