Will you kindly send us a quotation for the shipment of **fruit slurry (plums) to 3 destinations?** Please send quotations by **28 September 2026 at 12:00. Delivery must be door to door please. Samples are temperature sensitive and must be kept frozen if there are any delays during transit and customs clearance.**

MSDS attached.

Please provide clear international customs requirements to avoid any delays.

- Express delivery
- Non-hazardous samples (plum)
- Samples for analysis only not for consumption
- The samples have no resale value
- **Parcel description:** Cooler box with the following dimensions: height 26 cm; length 18 cm and width 26 cm, and weight of maximum 5 kg.
- **Material Description:**
 - The shipment consists of four 50 g samples of frozen plum slurry in new, clean, polypropylene screw cap bottles.
 - The plum slurry was prepared by blending plum with water and pesticides in parts-per-million levels (below the MRL for the pesticides in this commodity), there are no other ingredients.
 - The plums used were yellow plums (*Prunus salicina*) and their country of origin is South Africa.
 - The samples will be analysed for pesticides at the National Measurement Institute in various countries, as part of an international laboratory comparison (Supplementary Comparisons AFRIMETS.QM-S1) coordinated by the National Metrology Institute of South Africa, contributing to the mutual recognition of measurement capabilities among national metrology institutes.



- Freezing declaration: The material was frozen and continuously maintained at -18 °C or below until shipping, a period of greater than seven days. The shipment was packed with ice packs to keep the goods frozen.



- Should there be any delays during transit / customs, parcels must be kept frozen. Samples are temperature sensitive.

PREFERENCE POINTS CLAIM FORM IN TERMS OF NMISA SCM POLICY

This preference form must form part of all bids invited. It contains general information and serves as a claim form for preference points for Broad-Based Black Economic Empowerment (B-BBEE) Status Level of Contribution

1.5 Failure on the part of a bidder to submit proof of B-BBEE Status level of contributor together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.
