1. **Screening** – RFQ will be checked to ensure all documents are submitted, are signed (where relevant), are correct/valid and that the service provider is compliant in all aspects.
 - a. This will include the SBD6.2 (Local Content). Suppliers who fail to comply with the requirement for products which are 100% manufactured in South Africa and/or where products are not 100% locally manufactured submit the necessary approval from the DTI to deviate from the 100% requirement, will be immediately excluded from further evaluation. The supplier MUST obtain such approval in writing prior to the closing date of this request and a copy must accompany the submission.

Specifications

Bidders are required to supply and deliver prosecutor gowns – lower court as per the following minimum specifications:

NO.	SPECIFICATION	ADDITIONAL INFORMATION
1.	Material/Fabric	100% black polyester or equivalent not less than 180gm ² and even weave
2.	Embroidery	1. Gold NPA logo in front i.e. left and right of the yolk (shoulder piece). 2. Black braiding on the front (left and right buttons) just above the smocking underneath the embroidery. 3. Must be done in 1187 marathon cotton, mat, not shiny or lurex. 4. NPA logo must be clearly embroidered to show all details. 5. Size of embroidered logo should be 65mm wide x 55mm high. 6. Embroidery should be spaced 15mm above the laced trimming.
3.	Sleeves	1. Gold cord affixed to the black triangle with buttons on the left and right hand side of the triangle. 2. Triangle of 29mm x 29mm and 39cm at the hemline of the sleeve, finished with a 10 mm golden twisted cord, colour BCC 115 old gold. 3. Triangle at the centre of the sleeve with a covered button of 20mm on the inside of the triangle and at the corner of the triangle. 4. Button fabric should be of the same fabric of the rest of the gown. 5. Cord should be of the same colour as the embroidery of the emblem on the yokes. 6. Sleeves should be 1.6m wide at the hemline. 7. Sleeve seams should be finished with a false french seam and no over locking. 8. Sleeves should be of open bell sleeve style gown. 9. Head of sleeves should be gathered in 40mm deep smocking not wider than 3mm to 5mm piping of smocking. 10. Inside of sleeve must be finished with 100% polyester twill weave piping, no over locking. 11. Length of the sleeve should be in proportion to the gown and when fitted, it should cover cuff of the shirt or the sleeve of the jacket.
4	Length	1. The length should be the proportion of a person and the hemline more than 20cm above the ground.
5.	Yoke	1. Must have two embroidered logos of the National Prosecuting Authority, one on each side in centre of each side
6.	Lace Trimming	1. Must be stitched 10mm below the logo and above the smocking of the front panels. 2. End of lace trimmings, a 20mm covered button (of the same fabric as the rest of the gown) is sewn on the sleeves side of the yoke. 3. Three (3) rows of “s” – braiding is used and should be 40 mm wide.
7.	Width	1. Entire gown should be 1.6m wide. 2. Side seams must be finished with a false French seam and not over locking
8.	Front panels	1. Front panels must be gathered in smocking of 40mm wide. 2. Centre front panels are open in front and 60mm wide, finished with a stitching 10mm from centre front. 3. Back panel is gathered with the same smocking as the rest of the gown. 4. The centre front part of the panel is finished in a “v” shape.
