ANNEXURE A

Ffennell Rd Round building roof repair – 2025

The round building at Ffennell is made of a semi-circular structure, attached to a rectangular structure.

The rectangular building has only one floor, whereas the semicircular has 2 floors.

Repair at this stage is required on the roof of the rectangular building, which is made of 200 meter square.

Roof Slab Waterproofing

Recommendation of material to be used.

We recommend that the existing roof slab waterproofing membrane be replaced with a more durable, low-maintenance waterproofing membrane system.

The existing “torch-on” membrane should be carefully removed to prevent further damage to the existing roof screed.

Proper surface preparation need to be done before installation of the new membrane.

Any loose or flaky material should be removed/discarded and repaired prior to the application of the new waterproofing membrane.

We recommend the “Ecoseal-Armtec renew” waterproofing system because it does not have any joints which can often deteriorate over time and the maintenance costs are relatively cheaper than heat applied waterproofing membranes.

If any other material is used (which may have better quality than Ecoseal-Armtec, the technical spec and approval standard of that material need to be provided and properly demonstrated or explained.

It must be noted that, all the cracks and the spaces between slabs need to be sealed first before application of the sealant. The number of cracks will be confirmed during the site meeting.

After the old membrane has been removed, it must be properly disposed at the recommended dumping are.

The service provider shall indicate on the quotation where they shall dump the removed membrane (for conservation of the environment).

The warrantee on the material used must not be less than 2 years.

The warrantee on workmanship shall also not be less than 2 years.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

5. For the purposes of this Certificate and the accompanying bid, I understand that the word "competitor" shall include any individual or organization, other than the bidder, whether or not affiliated with the bidder, who:
 - (a) has been requested to submit a bid in response to this bid invitation;
 - (b) could potentially submit a bid in response to this bid invitation, based on their qualifications, abilities or experience; and
 - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
