1. Background

This Request for Quotation (RFQ) serves as an invitation to submit a quotation for the **Low Power Measurement Incorporation into EE Data Logger HMI** to the South African Bureau of Standards (SABS), in accordance with the SABS Standard Terms and Conditions of which a copy is available on www.sabs.co.za.

2. Confidentiality

This document may not be used for any purpose by the supplier other than for developing their response to it, and all reasonable efforts must be taken by The Bidder to ensure confidentiality of any information provided. This document and any other information of a confidential nature provided to The Bidder during the course of the Request for Quotation (RFQ) process are and will be covered by the non-disclosure agreement to be signed between the SABS and The Bidder.

3. No contract

Bidders shall note that this RFQ does not commit the SABS to any course of action resulting from the receipt of Quotations and the SABS may, at its discretion reject any submission which does not conform to instructions and specifications which are contained herein or select a Bidder based upon its own unique set of criteria. SABS also reserves the right not to select a bidder.

Nothing in this document shall be construed as a contract between the parties and no communication, whether verbal or written, by the SABS personnel or agents during the course of this process shall create such a contract in respect of the requirements specified in this RFQ.

4. No obligation to proceed

The SABS reserves the right to discontinue the RFQ evaluation process at any time and will not be responsible for any losses incurred by the Bidder as a result of discontinuance of the RFQ process.

The quotation shall remain valid for a period of no less than hundred and twenty 120 days from the submission date.

6. Specification: Low Power Measurement Incorporation into EE Data Logger HMI.

6.1 SPECIFICATION

In Appliances laboratory within the Energy Efficiency space, there are some appliances that have the passive standby feature (and other low power measurement features) built into their operational modes. These appliances are namely, the tumble dryers, clothes washing machines, washer-dryer combination machines, stove ovens and dishwashers.

In their respective test standards namely SANS 1695, SANS 50299, SANS 61121, SANS 60350-1 and SANS 50242, they all have to be tested for standby power in accordance with SANS 62301 for low power measurements. It is a mandatory requirement of SANS 941 test standard that all these appliances must be tested for standby power.

The existing energy efficiency test and data logging system proved not to be able to meet all the technical requirements to fulfil this requirement and therefore a need of incorporating a suitable low power measurement system into the existing system was identified as a best solution to be adopted to meet this test requirement.

Suitable power analysers have been identified with all the necessary features and will/ have to be procured and incorporated into the existing data logging system.

The supplier shall be capable of integrating this feature into the current custom data logging software specially developed for the SABS Appliance Energy Efficiency Laboratories. The upgraded Energy Efficiency Machine Data Loggers in each laboratory should read, log and display data provided by the Digital Power Meter.

They will also perform; HMI software setup, install, test and configuration of the custom data logging software onsite at SABS Labs.

6.4 Installation

The hardware (4x digital power meters) will be supplied to the service provider and be required to install it such that it talks to the existing data logging system.

6.5 Commissioning

The supplier is required to commission the **Upgraded Energy Efficiency Machines** Data Logging HMI and control and reporting application at SABS Appliance laboratories.



6.6 Training

Demonstration of the equipment use during the integration and commissioning of the system will be deemed as sufficient training to operate the units on low power measurements. Training manuals to be supplied at commissioning stage.

6.7 Documentation

The following PC documentation shall be provided:

4. Each person whose signature appears on the accompanying bid has been authorized by the bidder to determine the terms of, and to sign the bid, on behalf of the bidder;
5. For the purposes of this Certificate and the accompanying bid, I understand that the word “competitor” shall include any individual or organization, other than the bidder, whether or not affiliated with the bidder, who:
 - (a) has been requested to submit a bid in response to this bid invitation;
 - (b) could potentially submit a bid in response to this bid invitation, based on their qualifications, abilities or experience; and
 - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
