Proposals are hereby invited in terms of Section 83 of the Municipal Systems Act, Act 32 of 2000 (as amended) and Sections 110 and 112 of the Municipal Finance Management Act, Act 56 of 2003, for Insurance Services for 3 Years for the Inkosi Langalibalele Local Municipality.

Tenders are to be fully completed in full bond and in accordance with the conditions and bid rules contained in the bid documents and supporting documents must be placed in a sealed envelope and clearly marked **“Provision of Short Term Insurance for a period of 3 Years” quoting the relevant Bid Number** must be deposited in the Tender box at ground floor, Inkosi Langalibalele Municipality, Victoria Street, Estcourt, 3310 by not later than the date and time stipulated above, where they will be opened and registered in public (taking into consideration the gazetted Covid Regulations at the time of closing).

The Inkosi Langalibalele Municipality subscribes to the Preferential Procurement Regulations, pertaining to the preferential procurement policy framework act (PPPFA) principles whereby a tenderer's submission will be evaluated according to the sum of the award of points in respect of the tender value and the B-BBEE status of the tenderer. The tender will be evaluated on 80/20 as per the PPPFA Regulations and shall be based on pre-qualification, functionality and price. Bidders are required to submit a fully completed tender document issued by the Inkosi Langalibalele Local Municipality accompanied by a Company Proposal, company's CSD (Central Supplier Database) Report, Certified CIPC Documents, Certified Identity Documents of all Directors; Certified Valid Letter of Good Standing from the Department of Labour, Valid copy of the Tax Clearance PIN from the Receiver of Revenue, Rates and Taxes Statement obtainable from the Local Municipality, alternatively, Valid Lease Agreement. Please note that the onus is upon the tenderer to ensure that the Tax matters are **always** up to date.

Service providers operating in exempted areas shall submit an exemption letter obtainable from a Local Municipality.
