1. BACKGROUND

The Office of the Speaker is established and derives its powers/mandate from the Cooperate systems delegation, Governance model and Municipal Structures Act. The Office of the Speaker plays a coordination and management role for the council. The City of Tshwane amongst others, oversees and coordinates council and its committees and mandated to play Oversight on the executive and administration of departments in terms of the relevant legislation.

Its core mandate is to;

- Manage public participation through ward committees, stakeholder forums, petition processes, by-laws, etc., and enhancing the public participation role of the Speaker
- Providing effective strategic support to the units in the Speaker's office to enhance the role of the Speaker
- The Office of the Speaker has a mandate to facilitate community participation within the programs of the City through public participation, imbizos' and other stakeholder engagement forums identified by the city or any legislative or governance bodies.
- It aims to promote an interface between the City and the Community.
- The Office of the Speaker has been tasked with meeting the above objectives, the office needs to fulfil its public participation mandate by holding various relevant and necessary stakeholder meetings to promote active citizenry and address community concerns. We are also tasked to hold engagement sessions with traditional leaders on a quarterly basis.
- To involve the community in the affairs of the Municipality in terms of sections 16 and 17 of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000)
- To communicate information concerning community participation in terms of section 18 of the Municipal Systems Act, 2000

- To conduct orderly meetings of the City Council and Section 79 Committees : City of Tshwane Rules and Orders By-Laws, 2012

2. PURPOSE

The purpose of these Supply Chain Management specifications is to procure and appoint a suitably qualified service provider to provide specialised protection officers and the required operational equipment to maintain safety, security and order during Council proceedings.

3. SCOPE OF WORK SERVICES

3.1 The appointed service provider shall provide suitably trained, competent and PSIRA-compliant Protection Officers (Council Orderlies), together with the required operational equipment, to support the Office of the Speaker during Ordinary, Special and Continuation Council meetings held within the City of Tshwane.

3.2 The scope of services shall include, but not be limited to, the following:

(a) Provide trained and PSIRA-compliant Protection Officers for deployment during Council sittings.

(b) Deploy personnel at designated access control points at the Council Chamber, public gallery, and other areas as directed by the Office of the Speaker.

(c) Maintain safety, security and order during Council proceedings and protect councillors, officials, visitors and municipal assets.

(d) Respond to incidents of disorder, security threats and disruptions, including the lawful removal of disorderly persons on the instruction of the Speaker in accordance with the Rules and Orders By-law.

(e) Perform crowd management, conflict de-escalation and access control in accordance with applicable legislation and City policies.

(f) Submit written incident reports for all security-related incidents or as requested by the Office of the Speaker.

(g) Ensure all deployed personnel are properly uniformed, medically fit, suitably equipped with communication devices and remain on duty for the full duration of the deployment.

(h) Replace any officer who is absent or unable to perform the required duties at no additional cost to the City.

(i) Attend compulsory operational briefings and comply with all lawful instructions issued by the Office of the Speaker.

(j) Comply with all applicable legislation, PSIRA requirements, Occupational Health and Safety requirements, the City's security policies, and the Rules and Orders By-law.

4. DELIVERABLES

The appointed service provider shall:

- Supply the required number of Protection Officers for each Council sitting as requested by the City.
- Provide all operational equipment, including communication devices, required for service delivery.
- Ensure personnel remain available for the full duration of Council proceedings.
- Provide incident reports where applicable.
- Maintain service standards throughout the contract period.

4.1 SECTION ONE: APPROACH AND METHODOLOGY

This should cover:

1. The bidders understanding of the scope of work;

4.2 SECTION THREE: ORGANISATION AND STAFFING

4.2.1 Company Profile

Bidders must submit a comprehensive Company Profile, which must include:

- Company structure;
- Organogram clearly indicating management hierarchy and reporting lines.

4.2.2. Personnel Plan

Bidders must submit a detailed Personnel Plan outlining the experience of key staff, personnel allocation, and their respective areas of responsibility.

The plan must include the following information for the team assigned to the City's account:

- Organisational structure and reporting lines specific to this contract;
- Number of personnel to be deployed per assignment;
- On-site supervision and management structure;
- Contingency staff plan (to address absenteeism or emergencies);
- Full name and surname of each team member;
- Designation/Role (e.g. Supervisor, Team Leader, Security Officer);
- PSIRA registration number and grade;
- Relevant qualifications and certifications.

4.2.3 Dress Code

The appointed service provider must ensure that all deployed personnel adhere to the prescribed standard uniform as follows:

Male Council Protection Orderlies:

- White long-sleeve shirt;
- Black tie;
- Black blazer;
- Black trousers;
- Black shoes.

Female Council Protection Orderlies:

- White shirt;
- Black blazer;
- Black skirt or black trousers;
- Black shoes.

All personnel must present a professional, neat, and uniform appearance at all times during deployment.

5. SERVICE REQUIREMENTS

The CITY OF TSHWANE / OFFICE OF THE SPEAKER expects the successful bidder(s) to render the following services.

Bidders must clearly indicate the extent to which each requirement will be met and complied with.

5.1 General Specification: Council Protection Officers (Council Orderlies)

The successful bidder must provide:

Twenty (20) Protection Officers, consisting of:

- Fifteen (15) male officers;
- Five (5) female officers.

5.1.1 Technical Competencies

Deployed personnel must demonstrate the following technical competencies:

- **Security and Safety Protocols:**

Proficiency in understanding and implementing security protocols to ensure the safety of Councilors, dignitaries, and officials during council meetings and events.

- **Conflict Resolution:**

Ability to address and manage conflicts or disputes during meetings while maintaining a peaceful and respectful environment.

- **Crowd Control Management:**

Expertise in crowd control techniques to manage hostilities and prevent disruptions.

- **De-escalation Techniques:**

Ability to de-escalate tense situations and defuse potentially volatile incidents as and when requested by the Speaker of Council.

- **Emergency Response:**

Knowledge of emergency response procedures and the ability to act swiftly and decisively in the event of incidents during Council or related meetings.

- **Protocol and Etiquette:**

Sound understanding of municipal protocols, legislative procedures, and official etiquette to ensure the orderly conduct of meetings.

- **Crisis Management:**

Competence in handling crisis situations, including evacuation procedures and safeguarding participants.

- **Team Collaboration:**

Ability to work collaboratively with security personnel, law enforcement agencies, and municipal officials to ensure overall security.

5.1.2 Behavioral Competencies

Personnel must demonstrate the following behavioral competencies:

- Professionalism in conduct, appearance, and communication;
- Adaptability to changing or unexpected circumstances;
- Calm and composed conflict management;
- Empathy while maintaining authority and decorum;
- Integrity and ethical conduct at all times;
- Leadership, particularly during emergency situations;
- Clear verbal and written communication skills;
- Teamwork and collaborative engagement;
- Customer service orientation and respect toward attendees and Councillors;
- Attention to detail;
- Sound decision-making and problem-solving skills;
- Resilience under pressure;
- Customer focus;

- Initiative in preventing security risks;
- Emotional intelligence;
- Effective time management.

5.2 Transport Services

The service provider must provide:

- Reliable company transport for the deployment and operational support of personnel.

5.3 Security Equipment

- The bidder must demonstrate availability and access to the necessary tools of trade required for the execution of the contract, including but not limited to:
 - Two-way radios and communication equipment;
 - Transport vehicles for deployment;
 - Supervisory and reporting equipment.

5.4 CONDITIONS

5.4.1 The appointed service provider must comply with the following conditions:

- All deployed personnel must be South African citizens;
- Deployment of qualified security personnel who meet the prescribed individual standards;
- Appointment of a competent on-site Supervisor/Team Leader for each deployment;
- Personnel must possess recognised crowd control management certification;
- Ability to render services on an as-and-when-required basis, including evenings, weekends, and public holidays;
- Personnel must be proficient in English and at least one other official South African language;
- Personnel must maintain a high level of professionalism, neutrality, and presentable appearance at all times;
- Personnel must be physically fit, demonstrate situational awareness, and possess the ability to respond effectively to emergencies.

STAGE 3: PREFERENCE POINT SYSTEM

The preferential point system used will be the 80/20-point system in terms of the 2022 Regulations of the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000).

- 80 points for price
- 20 points for specific goals

Specific goals

Bidders are required to submit supporting documents for their bids to claim the specific goal points.

Non-compliance with specific goals will not lead to disqualification but bidders will not be allocated specific goal points. Bidders will score points out of 80 for price only and zero points out of 20 for specific goals.

The City shall act against any bidder or person when it detects that the specific goals were claimed or obtained on a fraudulent basis.

9. VALIDITY PERIOD

The validity period for the bid after closure is 90 days. City of Tshwane shall have right and power to extend any tender validity period beyond any initial validity period set and subsequent extensions. SCM shall ensure that an extension of validity is requested in writing from all bidders before the validity expiry date. Extension of validity shall be finalised while the quotations/bids are still valid.

10 MARKET ANALYSIS

The City of Tshwane reserves the right to conduct market analysis. Should the city exercise this option, where a tenderer offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the bidder if they will be able to deliver on the price, if a tenderer confirm that they cannot.

The bid will be disqualified on the basis of being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the supplier to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market related price with a bid scoring the highest points. If the tenderer does not agree to a market-related price, the city reserves the right to negotiate a market-related price with the tenderer scoring the second highest points, if the tenderer scoring the second highest points does not agree to a market-related price, negotiate a market-related price with the bidder scoring the third highest points. If a market-related price is not agreed, the city reserves the right to cancel the quotation.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;
 - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
 - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.
- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.
- 5 In order to give effect to the above, the attached Certificate of Bid Determination (MBD 9) must be completed and submitted with the bid:

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
