1. Introduction to C-BRTA

- 1.1. The Cross-Border Road Transport Agency (C-BRTA) is PFMA Schedule 3A Agency established through the Cross-Border Road Transport Act 4 of 1998 and provides advice, regulation, facilitation and law enforcement in respect of commercial cross border road transportation. The Act gives the C-BRTA mandate to licence commercial cross border road transport operators by issuing permits to operate. The provision of cross-border transport services in South Africa is subject to the provisions of the Cross-Border Road Transport Act. In terms of the Act, any person or organisation wishing to provide cross-border transport services must apply to the Cross-Border Road Transport Agency's Regulatory Committee for a Permit to conduct cross-border business.
- 1.2. The Cross-Border Road Transport Agency's (C-BRTA) thus exists, amongst others, to improve the flow of passengers and freight road transport in the region, introduce regulated competition in cross-border road transport, reduce operational constraints for the cross-border road transport industry, provide oversight and monitoring functions, and to improve the unimpeded transport flow by road of freight and passengers.

2. General rules and instructions

- 2.1. Bidders or their agents shall not make any news releases concerning this RFQ or the awarding of the same or any resulting agreement(s) without the consent of, and then only in co-ordination with, C-BRTA and its Client.
- 2.2. Bidders must be registered on the Central Supplier Database (CSD) to be able to conduct business with C-BRTA.
- 2.3. Any bidder who has reasons to believe that the RFQ specification is based on a specific brand must inform C-BRTA within three (3) days after the publication of the RFQ.
- 2.4. Bidders will be given seven (7) days to correct their non-tax compliance and three (3) days to fully disclose any information on the Standard Bidding Documents, failure such bidders will be disqualified.
- 2.5. This RFQ is subject to Government Procurement: General Contract Conditions – July 2011, Special Contract Conditions and any other contract conditions to be finalised during contracting.

5. Terms of Reference/ specifications

TERMS OF REFERENCE

Terms of reference guidelines should cover the following areas:

1. Project title

The purpose of this submission is to request the appointment of a property management entity for the rental of office space in Durban, KwaZulu-Natal for a period of 18 months.

2. Motivation and Background

- 2.1. The Road Transport Inspectorate (RTI) function transferred from RTMC to C-BRTA effective 1 April 2023. The regional lease agreements were ceded to C-BRTA, and the Agency continue with the obligations as contained in the lease agreements.
- 2.2. The lease agreement for the Durban regional office expired on 31 May 2024. The building leased for the Durban regional office is 200m² which consist of a reception area, 3 standard size offices, 1 large office, a boardroom, kitchen, walk-in safe and secure office/cash office in reception.
- 2.3. The procurement process commenced in the beginning of May 2024 during which consultations were held with the Senior Manager: RTI as well as the Regional Manager on space requirements for the office. The approved RFP submission was submitted to SCM on 27 May 2024 on Realyt (electronic signature system), however the submission was only received on 10 June 2024. This resulted in the delayed approval of the submission by SCM and further approval. Approval was granted for the variation from the contract for a period of 2 months (1 June – 31 July 2024) to finalise the procurement process.
- 2.4. The RFP was resubmitted and approved by SCM on 24 June 2024. The submission was thereafter submitted for consideration by CFO, however rejected. The document was rejected based on the discussions during Exco where RTI proposed to relocate certain offices to alternative locations for operational reasons. The relocation of offices are still in discussion and would require extensive consultations with affected employees.
- 2.5. In or around 16 July 2024, it was agreed that office space must be sourced in proximity of the current location, however leased for a shorter duration to allow time for consultation processes to finalise. The submission was submitted to SCM on 19 July

2024 for review, however feedback was only received on 31 July 2024. A second request for variation was approved for a period of 2 months (1 August – 30 September 2024) to finalise the procurement process.

- 2.6. Further delays were experienced as budget confirmation could only be provided on 13 August 2024 due to budget unavailability for office rentals.

- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

 - The percentage ownership by race category of each JV member or consortium member in each of the specific goals relevant to this bid.
 - The total points claimed will be the sum of the percentage contract allocation for each partner multiplied by the percentage weighting for the race category, multiplied by the percentage ownership in the relevant specific goal.
