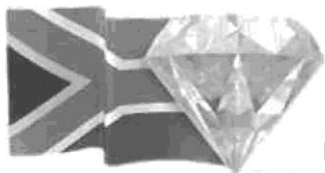

PHASE 2: The 80/20 Principle is based on Price and specific goals for SADPMR.
