Contract default and penalties

PROJECT TITLE	APPOINTMENT OF A SERVICE PROVIDER TO CONDUCT RISK MATURITY ASSESSMENT AT JCPZ

PURPOSE

A need has been identified within Johannesburg City Parks and Zoo (JCPZ) for the appointment of a suitable, qualified and an experienced external service provider to perform a comprehensive maturity assessment of risk management systems. JCPZ is seeking to appoint a suitably qualified and capacitated service provider, to carry out and conduct an assessment on the maturity of its risk management culture, systems, and processes. The assessment should be aligned to and in line with National Treasury Guidelines, latest IRMSA guidelines and recognized international best practices such as the ISO 31000.

BACKGROUND

Johannesburg City Parks and Zoo (JCPZ) is a non-profit legal entity wholly owned by the City of Johannesburg Metropolitan Municipality (COJ). It was established as a Municipal Owned Entity (MOE) mandated to develop, maintain and conserve the green open spaces and manage cemeteries in Johannesburg, as well as the Johannesburg Zoo. The Company has a portfolio in excess of 20 000 ha of public green open spaces including parks, cemeteries, nature reserves and approximately 3.2 million trees.

The company provides the following products and services:

- Urban parks, recreation and leisure facilities
- Cemeteries and crematoria
- Botanical services
- Nature reserves, including bird sanctuaries, nature trails, dams and lakes
- Environmental conservation, including biodiversity management and awareness
- Eco-tourism products and services
- Horticultural and arboriculture services
- Horticultural technical training
- Environmental and Conservation education and awareness
- Bio-aquatic management
- Zoological services; and
- Zoo conservation and research farm

In terms of the Local Government: Municipal Finance Management Act of 56 of 2003 (MFMA) section 95(c)(i) requires an Accounting Officer of a municipal entity to maintain an effective, efficient, and transparent system of risk management within the organization. This is also echoed by National Treasury Guideline and other best practice codes and standards such as COSO Framework, ISO 31000:2018 and King IV report on good governance.

Section 217 of the Constitution of the Republic of South Africa, 1996, provides that goods and services must be contracted through a system that is fair, equitable, transparent, competitive, and cost-effective and confers a constitutional right on every potential supplier to offer goods and services to the public sector when needed.

Anticipated contracting period for the project execution and delivery of defined outputs/deliverable is 30 working days. All expected deliverables and outputs must be delivered no later 7 working days after completion of the project. Dates for presentations of oral presentations to the management and the Board of Directors, will be communicated to the appointed service provider.

OBJECTIVES

The key objective in undertaking this assessment is to evaluate, determine and measure maturity levels of systems of Risk Management of Johannesburg City Parks and Zoo. The entity is undertaking the project strategically, in line with its objectives of ensuring good governance, service delivery excellence continuous improvement of systems and processes of risk management.

Through this project the entity should be empowered by taking best-practice improvement steps towards an integrated (optimal and efficient) enterprise-wide risk management program that will ensure world class service delivery and business performance.

SCOPE OF WORK

Potential service providers are expected to submit a detailed project proposal taking into consideration at the minimum the following key activities as part of implementing the project:

- Evaluate the overall Risk Management Culture, processes, and systems within JCPZ
- Evaluate and assess JCPZ risk governance policies and frameworks in line with the best practices and international standards such as ISO 31000:2018 Risk Management Standard and National Treasury and the IRMSA Guidelines.
- Evaluate and assess the Risk Management policies including but not limited to: The risk appetite and tolerance and implemented quantification methodology and aligned matrix, Evaluate, and assess the adequacy and effectiveness of Risk Assessment Processes (identification, analysis, and treatment process)
- Evaluate and assess the adequacy of the Monitoring and Review process
- Evaluate and assess the adequacy of Risk Reporting
- Provide recommendations based on findings
- Develop and present the Risk Maturity Assessment report and aligned output as detailed under the Key Deliverables and Outputs Section

FORMAT OF PROPOSAL

In the submissions or proposals, bidders must indicate the following:

- Proposed methodology that will be followed/utilised to undertake the review of JCPZ risk management maturity level.
- Detailed costs breakdown (inclusive of vat where applicable). The total bid price for the assignment must be based on the skills, resources and time allocated in providing the services. JCPZ reserves the right to request additional information or clarity on cost proposals prior to the evaluation thereof.
- Detailed plan indicating key activities and deliverables.

EXPECTED DELIVERABLES AND OUTPUTS

On completion of the risk maturity assessment, JCPZ expects to be provided with a maturity report, with actionable set of guidelines/recommendations that can help the entity on improving its ERM program immediately. Mainly, a detailed report should provide:

- ERM Maturity Assessment report on risk maturity level of the company.
- Maturity Improvement Plan, with recommendations on improvements to be implemented, addressing gaps identified during the assessment.
- The maturity improvement plan should address key risk ERM areas including the risk culture, systems and aligned process amongst other things. improvement roadmap
- High level Presentation at close out of the project, to be tabled to the Executive Committee and applicable Board Committee. E.g., Risk and Audit Board Committee.
- All expected deliverables and outputs should be delivered no later than 7 days after completion of the project.
