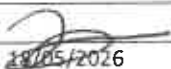

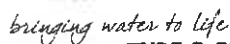

9.2.1 Deviation Process

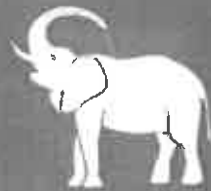

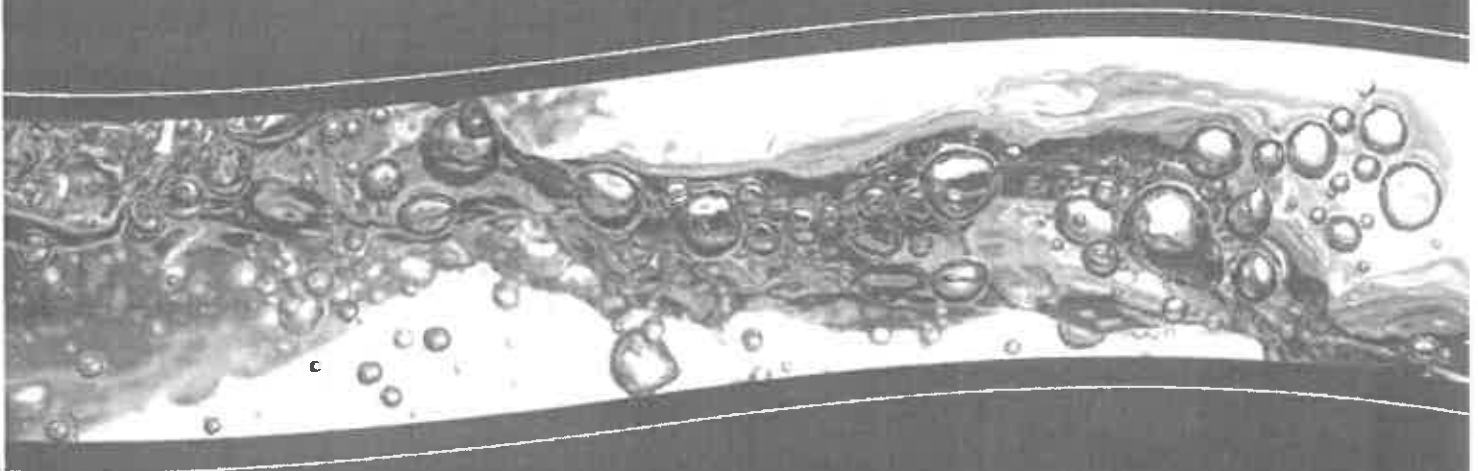

1. Purpose

It is motivated that Sole Supplier Selection be evoked for MH Communications for the provision of SSE Telemetry Equipment, Software and Services required by the Amatola Waters Telemetry system.

2. Background

Amatola Waters extensive Telemetry System consists primarily of SSE Telemetry equipment.

The original system was installed by SSE (Specialist System Engineering), a Centurion based company that was awarded a tender by the Department of Water Affairs in 1998. SSE appointed a local representative in the form of MH Communications to provide localized sales and service for their equipment. They have also supplied all additional outstations that have been installed over the years.

3. Discussion / Motivation

The Amatola Water Telemetry System is built on SSE Architecture - The same Architecture used by Joburg Water, Umgeni Water and many other Water Boards within South Africa.

The SSE System has served Amatola Water for over 20 years and continues to do so.

MH Communications have served as System Integrator for SSE since 2001 .

They are the only service provider licensed to sell SSE Equipment in the Eastern Cape.

It is essential that provision is made to allow for effective acquisition of SSE Equipment and Services in order to maintain and operate the Amatola Water Telemetry and SCADA Systems.

These Systems are essential to Operations and Management for the effect running of the reticulation off all AW Regions, as well as to the Auditors for the evaluation of Amatola Waters performance.

4. Risk Implications

Inability to effectively acquire SSE Telemetry Equipment will lead to a breakdown in Telemetry and SCADA Services.

This will accrue expenses as Operational Staff will be hindered in the performing their duties.

It will also lead to gaps in the Historical Record required for Auditing purposes.

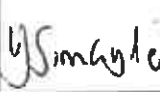
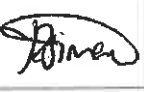
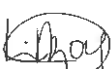
