



REQUEST FOR THE SERVICE PROVIDER TO COLLECT WASTEPAPER

1. BACKGROUND

- 1.1 As part of its operations, the South African Social Security Agency (SASSA) Shreds / destroys and handles a significant amount of documentation. The volume of these documents necessitates weekly wastepaper collection and secure disposal to prevent storage issues, comply with privacy standards, and support environmental sustainability initiatives. Proper management of these records is vital for protecting sensitive information, ensuring an efficient workflow, and maintaining the integrity of SASSA's operational procedures.
- 1.2 Proper management and disposal of these documents is crucial to maintain compliance with regulatory standards, protect sensitive information, and ensure efficient office operations. To address this ongoing need, SASSA requires a reliable service provider to collect wastepaper from its Head Office.
- 1.3 Previously, the number of bags collected weekly ranged from a minimum of 25 to 50 bags. However, there may be instances where a greater quantity needs to be collected, depending on operational demands.
- 1.4 The appointed service provider must be equipped with essential resources, including transport, trolleys, and personnel. In addition to these requirements, the service

provider is expected to ensure that all vehicles used for wastepaper collection are suitable for transporting large quantities of paper securely and efficiently. Trolleys must be sturdy and capable of handling heavy loads, facilitating the safe and easy movement of wastepaper from SASSA Head Office building to the vehicles. All personnel assigned to the collection process should be properly trained in handling confidential documents, adhering to privacy and security protocols during collection and transportation. Furthermore, the service provider should have contingency plans in place to accommodate fluctuations in the volume of wastepaper, especially in instances where operational needs require the collection of more than the typical weekly amount. To maintain accountability and compliance, all collections should be conducted in the presence of a SASSA official.

2. SCOPE OF SERVICES

The appointed service provider will be responsible for the collection of wastepaper from the SASSA Head Office Building for a period of five (5) years. The service provider is expected to deliver the following services:

- Conduct weekly wastepaper collections from the SASSA Head Office Building.
- Provide wastepaper collection services as and when required by SASSA, in addition to the regular schedule.
- Supply collection boxes of various sizes (x50 small and 50 big) as and when required, along with clear recycling bags, to be placed at photocopiers and workstations within the building.
- Provide trolleys to be used for the safe and efficient movement of wastepaper within the premises.
- The service provider to avail a weighing scale and weigh all wastepaper on site prior to removal.

- Ensure that a collection voucher is signed by a SASSA official prior to the wastepaper removal out of SASSA premises, with the original retained at the Head Office and a duplicate to main with the service provider.
- Provide digital educational material to support staff and stakeholders in understanding and implementing efficient wastepaper collection practices. For example, digital educational content may include step-by-step instructions, best practices for sorting and storing wastepaper, safety guidelines for handling materials, and tips on maximizing recycling efficiency.

3. CONTRACT TERMS AND CONDITIONS

- Enter into a formal Service Level Agreement with SASSA.
- Provide digital educational materials to SASSA regarding recycling practices.
- The appointed Service Provider to deposit payment/s for the collected wastepaper into the designated SASSA bank account on a monthly basis based on the amount of wastepaper collected.
- Remit payment to SASSA for the wastepaper collected.
- Ensure all collections are conducted in the presence of an authorized SASSA official.
- Submit a monthly remittance advice to SASSA, referencing the corresponding collection voucher number.

- a) Service Provider to attend a compulsory physical briefing session to be held at SASSA Head Office as per the date and time specified in the Request for Quotation.

6. BID EVALUATION

Bids will be evaluated in two stages as follows:

Stage One: Administrative Compliance

Stage Two: Price

6.1. Stage One: Administrative Compliance

6.1.1. Bidders are required to submit the following:

6.1.1.1. **Registration** with National Treasury Central Supplier Database.

6.1.1.2. **Completed SBD Forms:** Fully completed and signed Standard Bid Document (SBD) forms.

6.1.1.3. **Tax Compliance Status Pin:** A valid tax compliance status pin.

NB: Failure to submit any of the above may render the bid invalid.

6.2. Stage Two: PRICE

Offer Price

Bidders are required to specify their offer price for the collection of wastepaper from the SASSA Head Office. The proposed price should reflect the amount SASSA will receive, expressed as a cost per ton (**R/ton**). This price must be inclusive of the following:

- 3.4 In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications, prices, including methods, factors or formulas used to calculate prices, market allocation, the intention or decision to submit or not to submit the bid, bidding with the intention not to win the bid and conditions or delivery particulars of the products or services to which this bid invitation relates.
- 3.5 The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
- 3.6 There have been no consultations, communications, agreements or arrangements made by the bidder with any official of the procuring institution in relation to this procurement process prior to and during the bidding process except to provide clarification on the bid submitted where so required by the institution; and the bidder was not involved in the drafting of the specifications or terms of reference for this bid.
- 3.7 I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

NB: BEFORE COMPLETING THIS FORM, TENDERERS MUST STUDY THE GENERAL CONDITIONS, DEFINITIONS AND DIRECTIVES APPLICABLE IN RESPECT OF THE TENDER AND PREFERENTIAL PROCUREMENT REGULATIONS, 2022

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 **To be completed by the organ of state**

- a) The applicable preference point system for this tender is the **90/10** preference point system.
- b) The applicable preference point system for this tender is the **80/20** preference point system.
- c) Either the **90/10 or 80/20 preference point system** will be applicable in this tender. The lowest/ highest acceptable tender will be used to determine the accurate system once tenders are received.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (b) Specific Goals.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

$$Ps = 80 \left(1 - \frac{Pt - P_{min}}{P_{min}} \right) \text{ or } Ps = 90 \left(1 - \frac{Pt - P_{min}}{P_{min}} \right)$$

Where

- Ps = Points scored for price of tender under consideration
- Pt = Price of tender under consideration
- Pmin = Price of lowest acceptable tender

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

- P_s = Points scored for price of tender under consideration
 P_t = Price of tender under consideration
 P_{max} = Price of highest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
