SCOPE OF WORK

1. PURPOSE

The purpose is for Johannesburg Water (SOC) Ltd to appoint a Service Provider to relocate assets and equipment in two different buildings.

Pick up points:

- 5th and 6th floors, Thuso House, 61 Jorissen Street, Braamfontein and,

Drop-off points:

- 65 Ntemi Piliso Street, Newtown, to various building floors (ground to 3rd floor).

2. SCOPE OF WORK

1. The service provider to provide human resources which will be based at the departure points and destination point to coordinate the movement of assets and equipment.
2. To disassemble and reassemble furniture from the above-mentioned premises to the destination.
3. Johannesburg Water invites specialized service providers to come for compulsory site briefing to assess assets and equipment.
4. To execute and finalise the relocation of assets and equipment as specified herein within 3 days of award of contract.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
