1. Background

The SABS is a statutory body established in term of Standards Act, 1945 (Act No. 24 of 1945) and continues to operate in terms of the Standards Act, 2008 (Act No. 8 of 2008) as the national standardization institution in South Africa, mandated to:

- develop, promote and maintain South African National Standards;
- promote quality in connection with commodities; and
- render conformity assessment services and matters connected therewith.

2. Request for Quotation (RFQ)

This RFQ serves as an invitation to submit a quotation for the **appointment of a service provider for the repair and upgrading of an element endurance test bench at the Appliance Laboratory**, subject to the SABS Standard Terms and Conditions, of which a copy is available on www.sabs.co.za, accessible through the link: https://www.sabs.co.za/Procurement/proc_toc.asp

The Bidder is requested to supply its quotation, in writing, by the date specified. Should the Bidder require any clarification, the clarification should be submitted by e-mail to the Procurement Specialist identified in this document.

By submitting a quotation in response to this RFQ or participating in this RFQ process, the Bidder accepts that it is subject to and bound by all the terms and conditions contained in this RFQ document.

3. Confidentiality

This document may not be used for any purpose by the Bidder other than for developing their response to it, and all reasonable efforts must be taken by the Bidder to ensure confidentiality of any information provided. This document and any other information of a confidential nature provided to the Bidder during the course of RFQ process are and will be covered by the non-disclosure agreement to be signed between the SABS and the Bidder.

4. No Contract

Bidders shall note that this RFQ does not commit the SABS to any course of action resulting from the receipt of quotations and the SABS may, at its discretion reject any submission which does not conform to instructions and specifications which are contained herein or select a Bidder based upon its own unique set of criteria. The SABS also reserves the right not to select a bidder.

Nothing in this document shall be construed as a contract between the SABS and the Bidder, and no communication, whether verbal or written, by the SABS personnel or agents during the course of this process shall create such a contract in respect of the requirements specified in this RFQ.

5. No Obligation to Proceed

The SABS reserves the right to discontinue the RFQ evaluation process at any time and will not be responsible for any losses incurred by the Bidder as a result of discontinuance of the RFQ process

6. Validity of Proposals

The Bidder's quotation shall remain valid for a period of one hundred and twenty (120) days from the closing date. The SABs may at any time prior to the expiry of the bid validity period, extend the above validity period by sixty (60) days by written notice to the Bidders. In that event, the SABs will not require any consent from the Bidders, and bidders will not be required or permitted to amend any of their quotations.

The SABs retains the right, but is under no obligation, to request Bidders to extend the validity periods of their quotations, prior to expiry thereof, if it has already invoked the extension referred to above and it is in the SABs' interest to further extend the bid validity period. Such request shall be in writing. The Bidder is not obliged to extend the validity period. Also, bidders will not be required or permitted to amend any of their quotations.

7. SCOPE OF WORK: APPOINTMENT OF A SERVICE PROVIDER FOR THE REPAIR AND UPGRADING OF AN ELEMENT ENDURANCE TEST BENCH AT THE APPLIANCE LABORATORY.

7.1 PURPOSE OF THIS DOCUMENT

Testing of geysers (hot water storage heaters) in accordance with SANS 151 test standard, requires that all components used in the geyser must individually be tested to their respective test standards. This implies that geyser heating elements must be tested fully against their test standard, which is SANS 514 - Immersion heaters for electric storage water heaters. SABs Appliances laboratory is currently the only test laboratory in South Africa that is capable of performing full SANS 514 tests on geyser elements and is preparing to attain SANAS accreditation by April 2024.

The current equipment used to conduct thermostat endurance test is old and no longer reliable to produce trusted and credible test results. Geyser elements test lab being a critical test area to support testing of geysers, needs to be upgraded to match the modern technology and produce credible test results. This investment will further enable full automation of endurance testing of geyser elements. It will also ensure that test data is safely stored during testing up until the end of the test. The upgrade of the test bench will make the test to be fully automated and this will allow minimal intervention by the test officer, thereby increasing the availability of Test Officers to be utilized in other areas of the laboratory and/or the department at large.

		COMPLIANCE CRITERIA The heating element shall withstand the test given above without electrical or mechanical failure.
7.	Existing components that can still be used.	The existing test stations has tanks used to circulate the water. These are copper tanks, and they are still in a good condition to be used. It is therefore requested that the supplier uses the existing tanks as part of the upgrade.
8.	Test water	- The system must be able to log the temperature value (20 °C ± 5 °C) of the test water coming into the tank before it is heated up. - When the test water is heated up, it is noted that it is not thermostatically controlled, so it will heat up to whichever high temperature value, the temperatures must just be logged for all the test cycles. - The current test setup uses the test water only once in its test cycle. The scope of this project does not include a solution of circulating the same water to use for multiple cycles.

7.4 INSTALLATION

Full installation to be done onsite at SABS Groenkloof premises.

7.5 COMMISSIONING

Full commissioning needs to be conducted onsite at the SABS lab at the presence of SABS Test Officers. Commissioning report to be accepted and signed off by the responsible SABS Test Officer/s or Technical Lead.

Note: During commissioning the supplier shall demonstrate all material, design, product, or service functionality. This will be compared to the requirements described in this product specification. Compliance will be confirmed by both SABS and the supplier signing off against each requirement.

7.6 TRAINING

Onsite training during commissioning needs to be provided by the service provider.

7.7 DOCUMENTATION

The following System documentation shall be provided:

- User manuals,
- Software manuals.

Note: SABS will evaluate each document. SABS can decide at its own discretion if any document is not sufficient. In such a case the supplier will be responsible to update the document to SABS satisfaction.

7.7 SERVICES TO BE SUPPLIED BY SABS

The supplier is responsible for notifying SABS of any service that might be required for the installation, commissioning and operation of the equipment. This notification must be submitted together with the original quotation.

7.9 CONDITIONS

A proposed solution on how to achieve the requirements described in this document must be submitted to SABS

SELECTION CRITERIA

- Meet technical specifications specified in clause 3 above.
- Confirmation that the service provider will be able to provide local system support.
- 12-month warranty on both the equipment hardware and software.

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

NB: BEFORE COMPLETING THIS FORM, TENDERERS MUST STUDY THE GENERAL CONDITIONS, DEFINITIONS AND DIRECTIVES APPLICABLE IN RESPECT OF THE TENDER AND PREFERENTIAL PROCUREMENT REGULATIONS, 2022

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 **To be completed by the organ of state**

For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
